Education Updates



The recent statement from HM Chief Inspector is food for thought. It encourages us to reduce bureaucracy and focus on back on teaching and learning. The statement also asks us to deliver the curriculum based around the four capacities, values based learning and simple, clear curriculum linked learning opportunities.

As a context for learning, outdoor learning meets much of this expectation in a very authentic way. This entitlement to outdoor learning is echoed in many other policies:

- GTCS professional standards require every teacher to use outdoor learning
- For nurseries, Care Inspectorate expect daily contact with nature and outdoor play
- HGIOS4 inspections require regular and progressive outdoor learning
- The Curriculum for Excellence states 'outdoors is often a better place to learn than indoors'
- The Learning for Sustainability Vision 2030+ encapsulates all this and more

This means that in Scotland, outdoor play and learning should be a routine experience for all our learners, and that it is the responsibility of us all to support it.

Or, to put it in simpler terms, instead of 'should', we now 'have to'.

Our **Natural Play Project** has drawn to a close. It has been incredibly successful in transforming spaces, practices and attitudes towards play in schools across Scotland.

We directly worked with 60+ schools, changing practices and changing spaces. This work has inspired many more schools across Scotland, and it continues to delight us how many schools and authorities are working hard to improve outcomes through play.
