New Funding Opportunities

Lord Taverners Minibuses Grant Programme (UK)

The Lords Taverners, the UK's leading youth cricket and disability sports charity, has announced that its Minibuses grants programme will re-open for applications on the 1st May 2017. Last year the Lords Taverners, delivered 32 specially-adapted, wheelchair-accessible minibuses to schools, clubs and youth organisations across the UK. These vehicles give young people with disabilities access to new places and experiences. Lord's Taverners minibuses are based on the current Ford Transit model, with a diesel engine. The average cost to the charity of an accessible minibus is £52,500.

Applications will be accepted from schools/ organisations that cater for young people under the age of 25 who have a physical/ sensory/ learning disability. Please note that the Lords Taverners are unable to support schools that cater for socially disadvantaged children, or mainstream schools for children with behavioural problems.

Examples of recently funded organisations are:

- Seashell Trust a national charity that specialises in providing education and care for young people who have complex neuro-disabilities/needs; and
- Perseid School a community special educational needs school catering for 134 young people aged 3-19 with severe and complex learning difficulties.

The closing date for applications will be the 31st July 2017.

School Funding for Environmental Projects (England, Scotland & Wales)

Schools and local community groups can apply for funding of up to £2,000 through the Greggs Foundation for projects to improve the local environment. The Environmental Grant Scheme is funded by the 5p levy on carrier bag sales in Greggs shops.

Through the scheme funding is available to purchase equipment; sessional salary costs; purchase of trees/plants; small capital items; and learning activities.

The type of activities that could be funded include for example a growing project in a local primary school; a group of volunteers who completed litter picking exercises in their local parks or along a local riverbank; an allotment project for people suffering early stages of dementia; and clearing an area of wasteland in an area of high social need to create a community garden; etc. The Foundation are more likely to make grants to local organisations based near Greggs shops. For example, the Avondale Community Beekeepers are working with local primary school children to grow native wildflowers for their adopted beehives. This will provide vital forage and habitat for bees, as well as butterflies, ladybirds and other local wildlife. The project aims to engage children in the care and maintenance of wildflowers and their local environment, as well as educate them about the benefits of pollinators.

The closing date for applications is the 24th June 2017.

Funding for Football Facilities (England)

Grants of up to £10,000 are available to schools, grass roots football clubs, local authorities and professional and semi-professional football clubs and their associated community organisations that are looking to refurbish their existing or develop new football facilities.

The funding is available through the Football Foundation's Premier League & the FA Facilities Fund Small Grants Scheme and can be used to buy capital items such as portable floodlights, storage containers and other equipment; or to refurbish/improve existing facilities.

The aims of this scheme are to support the growth of football clubs and activity; prevent a decline in football participation; and make improvements to facilities to address any health and safety issues.

The grants awarded cannot exceed 50% of the total project cost. The Football Foundation strongly recommend that applicants use the pre-application advice offered on our behalf by The FA and the network of County FAs around England. This will normally involve completing the FA's Football Facilities Enquiry Form (FEF) first, which will help The FA to learn more about a project and determine the best way to support the applicant organisation.

Applications can be submitted at any time.

School Grants to Promote Physics (UK)

The Institute of Physics has announced that the next closing date for applications is the 1st June 2017. UK schools and colleges can apply for grants of up to £600 from the Institute of Physics for small-scale projects or events linked to the teaching or promotion of physics. Particularly encouraged are projects linked to astronomy, space and particle physics. Activities supported by the grant can include running a science week activity; organising a visit to or from a working physicist; supply cover; transport; marketing and publicity; materials/resources; etc.

Previous projects to receive funding include:

- Ampleforth College for a Visit to Jodrell Bank Radio Observatory; and
- St John's High School for a Practical Rocketry workshop to design a water propelled rocket.

The next closing date for applications is the 1st June 2017. The following closing date thereafter will be 1st November 2017.

One Stop Carriers for Causes (England and Wales)

Not for profit organisations, including schools that are located within 2 miles of a One Stop shop can apply for grants of up to £1,000 for projects that benefit their local community. The grants are available for a wide range of activities and the funding will cover the direct costs needed to deliver the project. Projects funded in schools include outdoor classrooms, learning zones, library equipment, a nurture room and playground improvements, etc.

Organisations that have received funding are:

- Crosby Scout and Guide Marina Club in Sefton was awarded a Carriers for Causes grant that has allowed them to invest in the next generation of young kayakers.
- Nelson's journey, a charity dedicated to supporting bereaved children and young people throughout Norfolk, to purchase digital cameras, a tripod and other accessories. The idea behind the project is to enable the charity to capture memories, helping them to remember that they are not alone in their experience.

Applications are shortlisted on a quarterly basis for panel decision which will take place every three months. Applicants will generally know the outcome of your application within 16 weeks of applying.

The Classical Association Grants (UK)

The Classical Association (CA), which awards grants to support classical projects and conferences has announced that the next closing date for applications is the 1st June 2017. The next deadlines thereafter will be 1st September and 1st December.

The Association will consider applications for summer schools and to institutions offering extra-mural courses in Greek, Latin and classical civilisation; bursaries for teachers attending courses abroad to support their professional development, notably the British School at Athens Easter Course; and school teaching and outreach work such as Greek and Latin reading competitions, regional Greek/Roman days and school conferences; etc.

Support for Environmental Outreach Education for Disadvantaged Young People (UK)

Schools, colleges and youth groups can receive up to 80% towards the costs of providing environmental outreach education for groups of disadvantaged young people through the Field Studies Council's Kids Fund.

The Field Studies Council is an independent educational charity committed to raising awareness about the natural world and works through a network of residential and day Centres in the UK to provide outreach education and training. The funding is available to help young people aged 14 - 18 (25 for those with special needs) attend a course who may otherwise be excluded due to some form of disadvantage - health, mobility, deprivation or financial. One free staff/adult place is provided for every 12 young people; additional adults pay 20% +VAT. This includes all equipment, tuition and waterproof hire costs. Food and accommodation are included for residential courses.

Examples of projects funded by the FSC include FSC BioLinks which brings together existing volunteers with skills in biological recording and identification, and new volunteers. The aim is to unite them in a community with a shared vision and sense of purpose by providing training and learning opportunities. This in turn will increase the quality of invertebrate species data being submitted to our national biodiversity datasets and develop individuals as more highly skilled biodiversity volunteers.

The next closing date for applications is the 1st June 2017.

Hong Kong Summer School Opportunity for UK Secondary School Students (UK)

UK sixth form secondary school students in the UK can enter a competition to win a place at a university summer school in Hong Kong. The deadline for applications is 14th April 2017. The competition aims to enable British students to experience Hong Kong's vibrancy and major tourist attractions, as well as to consider pursuing tertiary education in Hong Kong. The prize is a free trip to Hong Kong to attend a summer school programme at a Hong Kong university and have a genuine taste of the university campus life.

To enter students have to design a 48-hour travel itinerary for youth travelers visiting Hong Kong. The project should show how Hong Kong is unique and attractive to youth travelers. Students are also expected to compare travel experience between Hong Kong and a UK city. Entries can be through any means - an essay or through social media, for example a video clip on YouTube, a post in a blog.

Five winners will be selected and entries will be judged based on content, creativity and presentation. To be eligible for the competition, the student must be: a British citizen holding a UK passport and without right of abode or right to land in Hong Kong; in sixth form (Grade 12 or Grade 13) and studying full time at a secondary school in the UK; able to speak fluent English; able to support him/herself financially whilst in Hong Kong.

MoD Funding Available for Armed Forces Day Events (UK)

Individuals and local groups that would like to hold an event to celebrate Armed Forces Day can apply for funding from the Ministry of Defence.

The event can be anywhere in the UK and the funding can be used for a picnic in the park; themed BBQ; knees up in your living room; street party or fête; etc. Applicants should try to hold their event on or in the weeks around Saturday 24 June 2017.

The amount of funding the MoD will provide must cover 50% or less of the total costs of running the event and the deadline for submitting applications is the 30th April 2017. Event organisers should in the first instance register their event on the Armed Forces Day website.

Examples of events include:

- Armed Forces Day Community Concert on Mersea Island that will include will include local musicians, schools, colleges and community organisations/clubs; and
- Peterborough Armed Forces Day There will be performances, a parade, independent stalls, Military vehicles, Military Band, groups, charities, organisations involved with the Military, climbing wall, local schools involvement, local Cadets, Veterans, serving personnel, Pipe Bands, a flypast (weather permitting), etc.

Fields in Trust County Fund Opens for Applications (England, Scotland and Wales)

The Fields in Trust County Fund is open for applications. Grants of up to £5,000 are available to Queen Elizabeth II Fields in a number of areas across England. Fields in Trust protects and supports a wide range of sites including playing fields, multi-sport pitches, children's play areas, bicycle trails, nature reserves, country parks and many more.

Examples of what we could fund include:

- Playground equipment
- Sports equipment and facilities
- Improvements to existing facilities
- Improvements to access at the facility
- Outdoor fitness equipment

The funding is available to sites protected with Fields in Trust under the Queen Elizabeth II Fields Challenge. Please be aware that this is a small funding round and not all counties are eligible to receive funds. Areas that are eligible to apply are the following counties in England: Bedfordshire, North Yorkshire and Northumberland.

Funding is available towards capital projects and this can include playground equipment; sports equipment and facilities; improvements to existing facilities; improvements to access at the facility; and Outdoor fitness equipment.

There is no application deadline and the fund will close when all funds are allocated.

New Funding for Pupils with Special Educational Needs and Disabilities (England)

The government has announced that an additional £215 million of funding is being made available to transform the lives of thousands of children with special educational needs and disabilities by increasing school capacity and making it easier for them to access good school places. Every local council will be allocated at least £500,000 to invest as they see fit to help children and young people with education, health and care plans to get a high quality education.

The investment can be used in mainstream schools including academies, free schools, grammar schools, special units, special schools and further education colleges. It could be used to build new specialised classrooms for children with emotional, social and mental health difficulties, expand existing classrooms to increase their size for those using mobility aids, purchase mobility equipment and even create new storage facilities for wheelchairs.

Councils will be expected to consult with local parents, carers, schools, and others on how their funding should be used. They will be required to publish a short plan showing how they will spend the funding.

Funding for Community Recycling Projects (London and Watford)

Waste management firm Veolia has partnered with crowdunding website Spacehive to offer community groups in Greater London and Watford up to £1,000 through the Veolia's Community Recycling Fund.

The aim if the fund is to support projects that increase reuse and recycling within communities. This could include inspiring people and businesses to do the right thing with their waste; making greater use of recycled, reused or reclaimed materials; and protecting and preserving resources or enhancing local environments.

The fund is open to not for profit organisations, charities, community groups and schools. A total of £50,000 is available through the fund. To access the funding, organisations need to have successfully raised funding through Spacehive crowdfunding website for their project.

The fund will close for applications on the 30th April 2017.

Schools in Partnership Fund (London)

Registered charities, state schools and independent schools with charitable status who work in the boroughs of Barnet, Brent, Camden, Ealing, Hammersmith & Fulham, Harrow, Kensington & Chelsea, Westminster or City of London can apply for up to £50,000 from the Schools in Partnership fund. The fund aims to benefit the most disadvantaged young people and trustees believe that schools are uniquely placed to understand the dynamic between a young person's home-life and how support should be deployed there. The Charity encourages schools and charities to work together in groups and cluster arrangements, maximising limited resources to impact on a larger number of children and share learning and best practice.

Projects in the following areas have previously been supported: Emotional Wellbeing; Education and Learning; Children and Families; Special Needs and Disabilities. Schools that are currently receiving funding include: Childs Hill Primary School which received £112,000 over three years for a Play therapy project with Westminster Catholic Children's Society; Stanhope Primary School which received £90,000 over two years for an in-school psychology project; and Featherstone High School, which received £25,000 pa over three years for Addressing Underachievement: Promoting Success.

Applications are considered three times a year in March, June and November and the process takes at least six months to complete.

Funding Reminders

Grants to Promote the Teaching of Greek (UK)

The Hellenic Society Schools Sub-Committee makes grants to schools to assist projects concerned with the teaching of Greek or Greek civilization. Typically, grants are made for books; teaching materials, classics days or conferences; Greek plays by schools; and Summer schools.

Applications from schools planning to start courses in Greek are especially welcome. Applications on behalf of individual pupils or teachers are not normally considered, but a grant may be made to an institution for use as bursaries to individuals at the discretion of that institution. Most grants are in the range £100-£500, but larger awards are occasionally made.

Examples of previously funded projects are:

- The Friends of Burwell Village College Primary received a grant from the Society towards books and artefacts to help bring Ancient Greece to life; and
- Bishop Luffa School, Chichester received funding to set up a Greek club.

The next closing date for applications is the 1st May 2017.

Funding to Support Education in Disadvantaged Areas (UK)

Grants are available to support schools and registered charities that wish to undertake educational work with children and young people in disadvantaged areas. The British & Foreign Schools Society (BFSS) normally makes grants for educational projects totaling about £600,000 in any one year. The majority (85% of grants) are made to charities and educational bodies (with charitable status). Schools wishing to apply need to have either charitable status or "exempt charity" status.

Previous projects supported include:

- a grant of £10,000 to the Bloomfield Learning Centre. The Centre assesses and teaches 6 to 16 year olds with specific learning difficulties from areas of socio economic disadvantage in London specially Southwark, Lambeth, Islington, Camden and Greenwich;
- a grant of £33,240 to Afghan Association Paiwand (AAP) towards a new Saturday school in the deprived area of Colindale, North London; and
- a grant of £5,000 to the Lyric Hammersmith to support a programme of work for schools in West London to enable disadvantaged children to engage in regular cultural activity.

The closing date for applications is the 24th April 2017.

Funding to Support Joint Projects Between UK and French Schools (UK)

UK schools that wish to organise reciprocal visits to their existing partner schools in France can apply for funding of up to £5,000 through the Lefèvre Trust. The Trust must involve pupils aged 11 - 19 that work with their partner school on joint curriculum based projects. The programme aims to give more young people the knowledge, skills and understanding to work not only bilaterally but in a global context - and contribute responsibly to society - locally and globally.

The British Council will accept grant applications from schools, sixth form colleges and comparable institutions providing full-time general, vocational, technical or special needs education. Both private and government institutions are eligible to apply. For example, Barr's Hill School, Coventry received funding to liaise with Collège Roland Vaudatin near Saint Malo, France.

The closing date for applications is the 15th May 2017.

Holiday Grants for Children (UK)

From the 1st March 2017 schools, youth groups, not for profit organisations and charities are able to apply for a grant from the Henry Smith Charity' Holiday Grants programme. The programme provides access to recreational trips or holidays for groups of children less than 13 years of age who experience disadvantage or who have disabilities.

Applications can be made for grants towards a single trip, which could be a day trip or a longer residential of up to seven days in length. This could be to a countryside or city location but must be outside of the children's immediate locality.

Examples include camping, trips to adventure activity centres or the seaside. Grants of between £500 and £2,500 are available; to cover a maximum of two thirds of the cost of a holiday or trip, the remainder of the funding must be raised elsewhere.

Examples of recent grants are:

- Canon Barnett Primary School in London received £625 towards a four-night trip to an outdoor adventure centre for a group of disadvantaged children from the London Borough of Tower Hamlets;
- Great Wishford Primary School received £650 towards a five-day trip to an adventure activity centre for a group of disadvantaged children from Wiltshire; and
- Merton Bank Primary School which received £1,900 towards a two-night trip to an outdoor pursuits centre in Lancashire for children from a deprived area of Merseyside;

Applications for trips that take place between the 1st May and the 30th June 2017 are been accepted until the 19th May, decisions are made on a first come-first served basis (within the application periods stated) until funds are spent.

Partnership in Learning Fund (UK)

UK-German Connection an organisation dedicated to increasing contacts and understanding between young people in the UK and Germany has announced that its Partnerships in Learning funding programme is open for applications. The funding programme aims to support UK-German school partnerships undertaking a variety of educational activities in both countries, including peer learning, with a flexible thematic and cross-year approach relevant to the curriculum. The maximum grant available is £5,000, which is to be shared between the participating schools to support costs such as travel and accommodation for reciprocal partner visits, project resources and joint activities. Applicants must contribute at least 25% of the overall eligible activity costs through participants' contributions and other sources of funding.

For example, Wishaw/Shotts Youth Exchange Group in North Lanarkshire and Kreisjugendring Wunsiedel worked on an exchange to promote European citizenship and investigate what life was like living on a border.

The deadline for applications is the 31st May 2017.

Equipment Grants for Mentally & Physically Disadvantaged Children (UK)

Schools and not for profit organisations have the opportunity to apply for funding through the Wooden Spoon Society's Capital Grants programme. Wooden Spoon the British and Irish Rugby charity which supports mentally, physically disadvantaged children. Through the programme funding is available for buildings and extensions; equipment & activity aids; sensory rooms and gardens; playgrounds and sports areas; transport and soft playrooms. Since being founded in 1983, Wooden Spoon has made grants of over £20 million to more than 500 projects in the British Isles.

Projects funded in the past have included:

- Ashmount School in Leicestershire, which received a grant of £13,500 towards a sensory room;
- Enfield Heights Academy in London which received a grant of £23,000 to improve its play areas; and
- the Colehill &Wimborne Youth & Community Centre which received a grant of £8,000 towards a wheelchair lift.

Applications can be made at any time and applicants should contact their regional volunteer group. Subject to an application being approved by Wooden Spoon Trustees, the Society require a minimum of one Wooden Spoon membership to be taken out by a representative of the applicant organisation. New Grant to Mark the Centenary of WWI (UK)

School that wish to develop projects that improve the understanding of World War I can apply for grants of between £3,000 and £10,000 through the Heritage Lottery Fund's (HLF) new £6million small grants programme "First World War: then and now". The aim of this new grants programme is to help communities mark the Centenary of the First World War.

The programme will award £1 million per year for six years. HLF want to fund projects which enable communities to understand more about the heritage of the First World War. In particular, HLF would like to help young people aged 11–25 to take an active part in the Centenary commemorations. Focusing on the identification, recording and preservation of local heritage; the creation of community archives or collections; exhibitions, trails, smartphone apps and creative material such as plays and music based on heritage sources, the idea is to create an enduring cultural and educational legacy for communities.

For example, the following projects have been funded:

- YMCA North Tyneside received £9,600 for a project that involved local schools, youth groups and young carers working with YMCA North Tyneside, the Tynemouth WW1 Commemoration project and Age UK to explore what life was like for young people during the First World War. Young people took part in a programme of activities, including interviewing people from Age UK about their family history and going on a photography trip to visit five war memorials. With the help of Y Studios, the young people edited the interviews and photographs for use in the final exhibition at Tynemouth Metro Station.
- Museum of the Broads in Norfolk received £10,000 for a project that explored the impact of the First World War on the people of Broadland, from the perspectives of the men who went to war and those who remained at home.

First World War: then and now is a rolling programme, and applications can be submitted at any time until 2019.

Funding for Chemistry Clubs at Schools and Colleges (UK)

Schools and colleges can apply for grants of up to £1,000 to run chemistry activities. The funds which are made available by the Royal Society of Chemistry, are targeted at activities run at schools and colleges outside the normal science timetable. Activities should be focused on generating interest in chemistry in all ability levels or which may provide opportunities to stretch and challenge the already able and motivated students.

Applications from existing chemistry clubs looking to expand/ enhance activities would be welcome as would those from schools and colleges interested in starting a new club. An application would need to indicate how the longevity of the proposal was ensured and how best practice and experience from it might be shared within and between other (perhaps feeder) schools. The application must be made by a teacher at a primary or secondary school.

The Naturesave Trust - Community Renewable Energy Grants (UK)

Naturesave Limited, an ethical insurance company provides funding to support environmental and conservationist projects. The funding is provided by investing 10% of personal insurance premiums into the Naturesave Trust The Naturesave Trust aims to provide financial assistance to projects that deal with the root of a specific environmental and/or conservationist problem and those that encourage the greater commercial adoption of sustainable development. Financial assistance is available in the form of start-up finance to new organisations which seeks to promote greater awareness of sustainable development or for existing companies and charities which are seeking funding for a specific project.

Recently funded projects by the Trust include Pilling St John's Primary School which received funding towards the installation of a wind turbine at the school, providing energy and income to the school; and Great Oaks School which received funding for a wildlife pond & meadow.

Funding for Projects that Raise the Attainment of Disadvantaged School Students (England)

The Shine Trust which funds projects that help disadvantaged young people to realise their academic potential, has re-opened the Let Teachers SHINE competition. The competition aims to find the country's best teachers and some new and practical ways to raise attainment among disadvantaged students in literacy, numeracy and/or science. Funding of up to £15,000 is available for 10 winning ideas. The competition is open to any teacher working with students aged up to 18. Successful ideas might involve superb after-school programmes or innovative use of technology; etc.

Previous competition winners have included:

- Mike Baldwin's research project on his forest school. The woodland-based curriculum helps children with severe learning disabilities to learn new words, develop functional speech, and encourages them to meet their own sensory and physical needs;
- a teacher who uses Tibetan debating techniques (which involve actions as well as words) to help improve communication skills among primary students; and
- a teacher in Wimbledon, who wants to boost interest in science, technology, engineering and maths by challenging girls to research, create and market a new cosmetic product.

The closing date is noon on the 24th April 2017.

Greggs Foundation Breakfast Club Grants (England, Scotland & Wales)

The Greggs Foundation currently supports 380 breakfast clubs throughout England, Scotland and Wales. Schools that are interested in opening a breakfast club at your school must be able to show that at least 40% of your pupils qualify for free school meals and that the school serves a disadvantaged community. School should able to attract adult volunteers to help run the scheme and attendance at the club must be free for all pupils.

The Foundation uses the money to support breakfast clubs through an initial startup grant for equipment such as chest freezers to store food items or toys and activities for the club. Greggs Foundation also makes a payment each term towards other food items and Greggs plc donates bread from the nearest shop.

Recently set up breakfast clubs include:

- "Clubs" at Hillside Community Primary School, in Skelmersdale which received funding of £600 for its breakfast club which around 45 young people attend each day; and
- Swalwell Primary School, in Gateshead where nearly 50% of school children are entitle to free meals received a grant of £1,100.

Although applications can be made at any time, there is currently a waiting list for funding whilst new sponsorship partners are being identified.

The ASDA Foundation trust was set up in 1988 to support local good causes chosen by employees and is funded by profits from the mid-week national lottery. Some of the projects that the ASDA Foundation has supported in the past include:

- Transforming a large tarmac playing ground at Haslingden Primary School, Lancashire, into a place where children can play, learn, enjoy, plant and grow, and most of all have fun.
- £7,000 to the Old Leake Community Centre the Centre hosts local groups to support local community. The donation will fund the refurbishment of the kitchen. This will provide better access for people with various disabilities and also bring the facilities up to current legislation.
- The Foundation also provides funding for the Southglade Park community allotment, a nonprofitable initiative where the produce grown is used to educate young children and adults on healthy eating.
