## Word Problems

1 ) Nancy likes to collect coins. Nancy got 26 coins from her brother, 37 coins from her mother, as well as 21 coins from Benny. However, Nancy lost 35 coins before putting those coins into her piggybank. How many coins does Nancy have in her piggybank?

2 ) Sara wants 180 cupcakes for her party. Sara has already made 60 vanilla cupcakes, and 72 mocha cupcakes. How many more cupcakes does Sara need to make?

3 ) At an amusement park, Mary wants to ride a rollercoaster that costs 23 tickets, a bumper car that costs 18 tickets, and a merry-go-round that costs 33 tickets. Mary had 31 tickets, but lost 9 of them on a ride. How many more tickets does she need?

4 ) Sandy had 172 kitty stickers. Sandy gave 25 stickers to Sara, 32 stickers to her sister and an additional 62 stickers to Fred. How many stickers does Sandy still have?

5 ) Mike made 3 different stacks of wooden blocks. The first stack was 6 blocks high, the second stack was 6 block(s) higher than the first, and the final stack was 6 block(s) higher than the second. In total, how many blocks did Mike use for all 3 stacks?

6 ) For softball season, Jess decided to buy a ball for $\$ 5.20$, new shorts for $\$ 19.70$, as well as a pair of softball shoes for $\$ 40.00$. Jess currently has $\$ 21.30$, and a coupon for $\$ 14.00$ off her purchase. How much more money does Jess need to complete her purchase?

7 ) Sandy wants several different color plates for her birthday. Sandy wants to get 144 silver plates, 108 cyan plates, and some amount of green plates. In total, Sandy wants 372 plates, so how many green plates should she get?

8 ) Before getting to school, Keith has a few errands to run. Keith has to walk 8 blocks to the gallery, and 6 blocks to the library, before walking the final 11 blocks to arrive at school. If Keith has already walked 12 blocks, how many more blocks must he walk before arriving at school?

9 ) For lunch, Mary bought a glass of water for $\$ 1.40$, a bacon sandwich for $\$ 4.70$, as well as some sherbet for $\$ 3.00$. The tax came out to $\$ 1.70$, and Mary paid with $\$ 15.00$. How much change should Mary receive?

10 ) Nancy wanted to save money to buy a new outfit. Nancy saved $\$ 25.20$ in May, $\$ 25.70$ in June and $\$ 20.40$ in July. However, she also had to spend $\$ 29.60$ on school supplies and $\$ 43.40$ on her dog. If the outfit costs $\$ 135.50$, how much money does Nancy still need to save?
