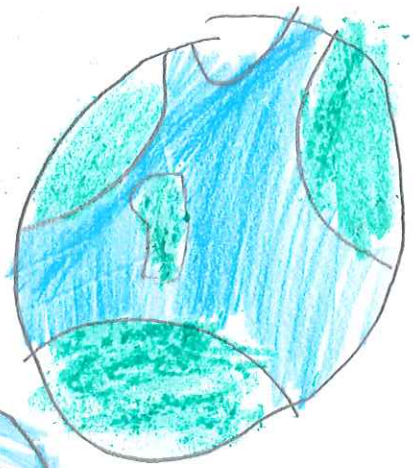

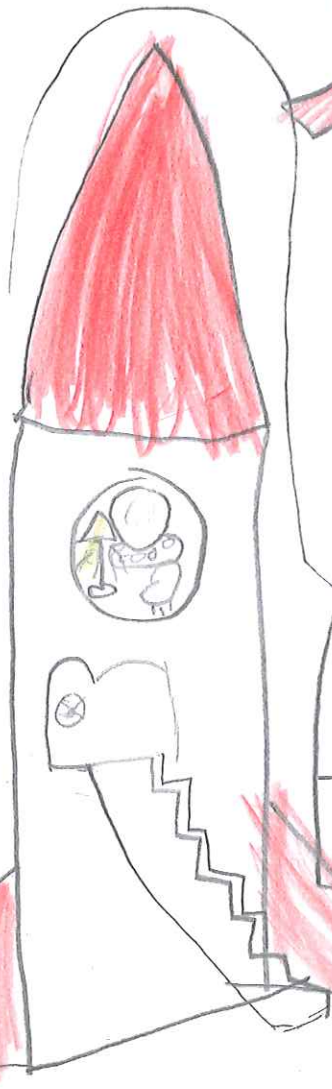

Chapter 1 Lets go ^{Tommy}

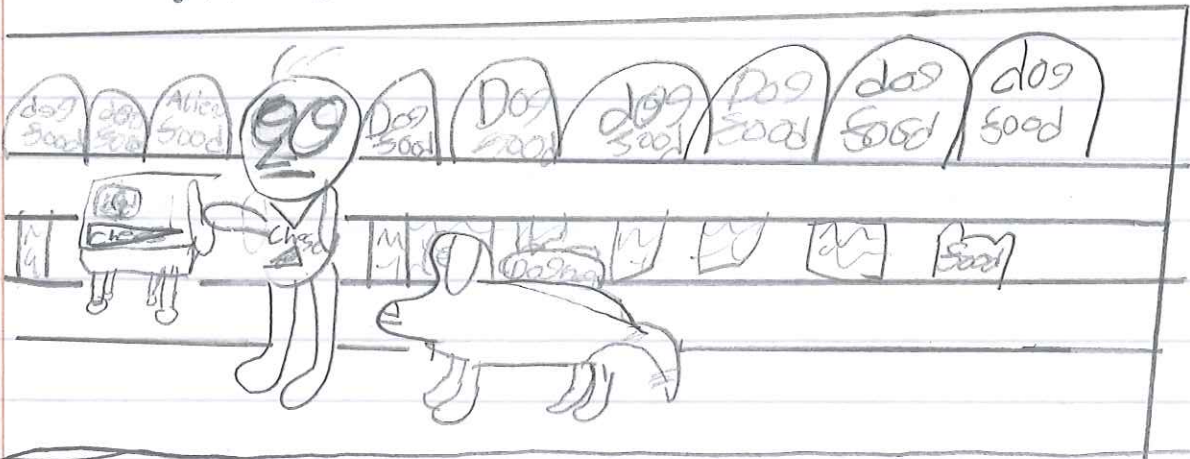

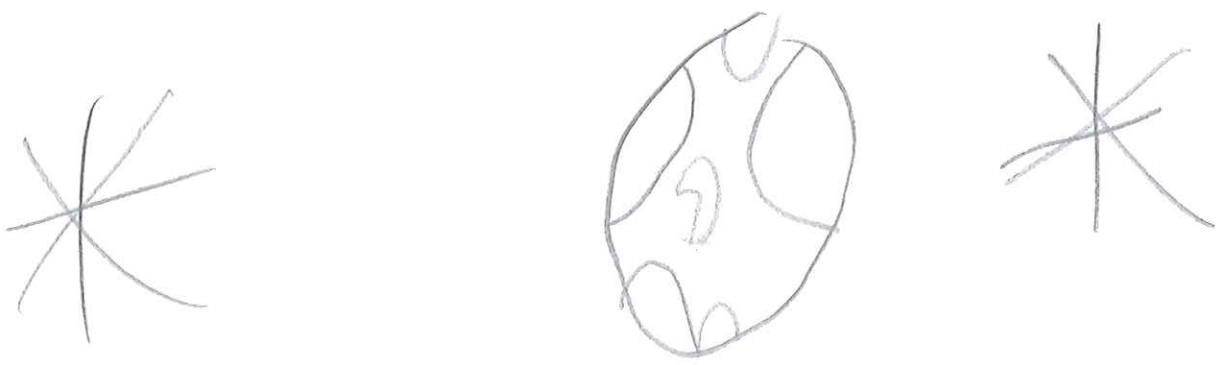
Chapter 3 to the moon

moon ~~glakes~~ shop

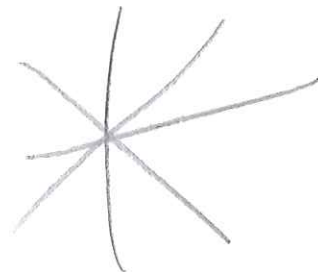
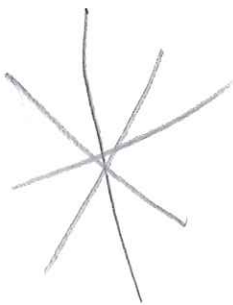
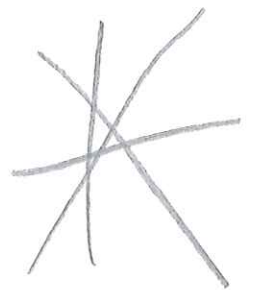


OK what should we get now clates quick
