This document has been issued by East Ayrshire Council for Proposal in terms of the Schools (Consultation) (Scotland) Act 2010, as amended.

1. NOTICE OF PROPOSAL

This document is a summarised version of the full Proposal Document which has been issued in relation to the future of education provision at:

- > Auchinleck Academy; and
- Cumnock Academy and Supported Learning Centre

In addition, pupils attending the following primary schools and special school are also affected by the proposal document to which this notice relates, namely:

- > Barshare Primary School and Supported Learning Centre and Early Learning Centre
- > Greenmill Primary School and Early Learning Centre; and
- > Hillside School

2. BACKGROUND

The schools rationalisation programme has been established to deliver a key element of East Ayrshire Council's School Estate Management Plan and Transformation Strategy, which aims to achieve an average 85% occupancy rate for the whole school estate. Currently Auchinleck Academy has an occupancy rate of 54.1% and Cumnock 59.5%. The proposal being put forward clearly encompasses addressing occupancy through merging the two academies and through co-location with other establishments. The benefit associated with successful completion of this project is unprecedented and delivers for the communities concerned through improved quality of educational experience from 2-18 years, outstanding opportunities for a community involvement approach to link Further Education, Higher Education and Business Enterprise in the project. The massive investment totaling £63.5m will transform provision into a unique approach which links all aspects of lifelong learning.

3. THE RELEVANT PROPOSAL

In formulating this proposal East Ayrshire Council undertook a pre-consultation exercise with the Parent Councils of all establishments involved, noting their positive response, their comments, and their concerns. A set of frequently asked questions was also developed and is available through the consultation section of East Ayrshire Council's website at www.east-ayrshire.gov.uk.

The proposal is that subject to the outcome of this consultation exercise:

- Education provision at Auchinleck Academy be discontinued with effect from June 2019 or as soon as possible thereafter.
- Education provision at Cumnock Academy and Supported Learning Centre be discontinued with effect from June 2019 or as soon as possible thereafter.
- The children and young people attending these establishments transfer to a new merged secondary school with effect from August 2019 or as soon as possible thereafter:
- The site of that school will be in the area of Cumnock presently occupied by Broomfield Playing Fields.

- That the delineated area of the new secondary school be created from August 2019 or as soon as possible thereafter, from the amalgamation of the delineated areas of the present Auchinleck Academy and Cumnock Academy and Supported Learning Centre.
- Views are also sought that the newly merged Secondary School and Supported Learning Centre should be co-located with a newly merged Primary School, Early Childhood Centre and Supported Learning Centre resulting from the amalgamation of Greenmill Primary School and Early Childhood Centre and Barshare Primary School, Supported Learning Centre and Early Childhood Centre, and a new build Hillside School on the Broomfield site.
