#### 1. Welcome

CD welcomed everyone to the meeting.

#### 3. Minutes of Last Meeting

### 6. PCSG Update

CD provided an update on the meeting of 3 May. There had been an excellent presentation in explaining and quantifying the "attainment gap" and demonstrating the improvement that various interventions had made. ACEL data for Lochnorris to be provided at next meeting. Discussion of vaping issues in schools – not currently seen as an issue at Lochnorris but proximity to RBA a factor. Discussion of new school app – seems to be working well at Lochnorris compared to other schools. SLT noted that there are only 400 downloads to date, so not all parents/carers have signed up and may be missing out on information. To be addressed.

#### 7. School Improvement Plan and PEF Budget

CO'D advised that there were only 3 responses to the focus group so she decided not to go ahead.

There were only 17 responses to the survey, but members noted that they had not been aware of the survey.

CO'D advised that PEF would be used for classroom assistants, boost groups to help children catch up, breakfast club, a curriculum refresh and retaining the management team size outwith classes.

CO'D noted that she could not advise on the improvement plan as she had not yet written it, but it would include the Harmony Project and targeting attendance.

#### 9. Head Teacher Update

#### CO'D to share slides

CO'D provided the update:

- Staffing has now been finalised. With 3 P7 classes leaving and 3 P1 classes joining, classes moving up as is. However, the new P6 is oversubscribed and there is no capacity for another classroom, so the new P6/7 will have 27 pupils and be open to new joiners. As this is above the 25 person limit for a composite class, 2 teachers will be in the class. CD noted that parents had made contact to raise concern about the arrangement. CO'D committed that the 2 teacher arrangement would be fixed and not the first point of compromise to cover absence. Members raised concern that the building had already reached capacity with no ability to create an additional classroom (to consider raising with EAC in future). For 23/24 probationer teachers will be in P1 and P4, supported by the 2 PTs
- Discussion around parental engagement and involvement, including garden and reading groups.
- Funding group has 7 parents and 5 staff. Planning a sponsored walk.

### 10. AOCB

In relation to the social media concern about the café, no approach has been made direct to the school. CO'D provided assurance that children are never left unsupervised in the reception area.

CD asked if there was potential to use local suppliers of school photos, particularly given EAC focus on Community Wealth Building.

Information on the P7 residential for 23/24 to be provided to parents as soon as possible to assist with household budgeting.

Record of thanks to parent council members who have children in P7 and will not return in the new term.

P1 transition event (next day) SLT to remind parents about the app and raise awareness of Parent Council membership.
