Willowbank

GD encouraged PC members to participate in the consultation process, (which has been postponed) observing that:

- The consultation proposes using a small area of a small campus to relocate S1-S6 from Willowbank to St.
 Joseph's Campus in a move that's favourable for neither part
- Now that the whole of Willowbank Secondary is proposed to move (as opposed to S4-S6 in original proposal)
 that the proximity to St Joseph's argument is no longer valid, as it is effectively the creation of a new school
- There is only one option for consultation
- The target occupancy date of January 2022 is very ambitious
- That another consultation (Supported Learning Centres) is due to be carried out in December
- The proposed locations of St. Joseph's facilities and services displaced as a consequence of the proposed relocation of Willowbank appear to be an afterthought
