SQA Appeals

One hundred and sixty-five individual course results qualify against appeal criteria. Where pupils request that we submit an appeal on their behalf we will do so. Various information has been shared with pupils since the release of exam results. No pupils are awaiting priority appeals. All results will be communicated to pupils in late October/early November.

SQA Courses 2022/23

Prior to summer, SQA confirmed that course changes made in 2020/21 and refined in session 2021/22 would remain in place for session 2022/23. This means that in some subjects, course components will not be assessed e.g., Science Investigation.

We await clarity on whether study guides similar to those released in 21/22 will follow (in advance of examinations).

ParentPay

Parents/Carers of our new S1 pupils were issued with ParentPay letters on Friday afternoon and via email.

Lockers

Communication on securing a locker will be sent out shortly and following the conclusion of IT setup across all systems.

Glow

Satchel: One (ShowMyHomework)

S1 accounts are now synced. This morning, office staff started to email Satchel: One access codes to parents/carers of those in S1. Anyone else with access issues should contact the school request further support.

EMA Applications

EMA (Education Maintenance Allowance) learner agreements need to be scanned and sent electronically. If anyone needs their agreement scanned, please hand the paper version into the school office. Various reminders were sent over summer as to the steps that needed to be taken to register for EMA.

Working Time Agreement

The Working Time Agreement governs the use of staff time within each school. The WTA is agreed in collaboration with staff and professional association representatives and details the dates of parents' evenings and reports.
