UCAS APPLICATIONS FOR 2021 ENTRY
APPLICATION PROCESS

Applications for entry to the Engineering Academy must be made on UCAS using one of your five choices. The programme code on UCAS is 0BRT. There is no need to complete a separate application for the HNC programme which is delivered in Year 1 within the Partner College.

The minimum entry requirements for the programme are 4 Highers at Grade B including Maths and Physics. For those applicants wishing to study Chemical Engineering, you must also have Higher Chemistry at Grade B in addition to Maths and Physics. For those applicants wishing to study Biomedical Engineering, you must also have Higher Biology at Grade B in addition to Maths and Physics. Please note that for those applicants from a widening participation background, offers will be made using contextual data information, details of which are available on the University's website: <https://www.strath.ac.uk/studywithus/wideningaccess/>

Once your application has been received by the University we will contact you to confirm receipt of your application and to ask you to confirm your preferred choice of degree programme at the University that you would wish to study. We will also ask for your preferred choice of College to study at in year one.

If we are in a position to make an offer for entry to the Engineering Academy, details of your offer will confirm the college which you will attend during the first year and the degree programme that you will transfer to following your 1st year at college. The College allocated will be based on the HNC programme which is relevant to your degree programme as well as for ease of travel. You will be able to view details of any offer received via your UCAS account. Please note that if you do receive an offer, you will have to accept or decline it by the deadline set by UCAS. If you receive and accept a conditional offer for entry to the Engineering Academy, we will review your qualifications against the conditions of offer at the point we receive them. If you are applying based on SQA Highers/Advanced Highers, this will be done after the SQA results day at the beginning of August. If you are applying based on an Access qualification, we will liaise with your Access provider to receive details about your attainment. Again, this will take place at the beginning of August.

If you are applying based on other qualification (i.e. European qualification), we ask that you send copies of your attainment certificates to the admissions team at your earliest convenience to be checked against the conditions of your offer.

If you receive and accept an unconditional offer, your place on the programme is secure and there is nothing further that you need to do.

Following the SQA results day in August, we will confirm the final intake and will begin the process of sending your details to the relevant college you will attend throughout first year. They will be in touch with regards to start of term information.

You will also be required to apply for SAAS funding and further information can be found at: <http://www.saas.gov.uk>. Please note that for the first year of the programme you will require to apply for SAAS funding using the College as your institution. We will send you the information you require to apply for SAAS funding once your offer has been accepted.

Applying after the 15 January Deadline

We will accept new applications after the 15 January deadline.

1. If you have not submitted a UCAS application for any other courses:

You can apply to the BEng Engineering Academy course through UCAS using Institution Code S78 and Admissions Code 0BRT.

2. If you have already submitted a UCAS application to an Engineering course at the University of Strathclyde:

The Faculty of Engineering has internal processes in place whereby applicants who apply directly to their chosen degree programme who do not meet the minimum entry requirements will be given the opportunity to transfer the application to the Engineering Academy, should their application be suitable for consideration.

We can also arrange for your application to be transferred over to the BEng Engineering Academy admissions code at any time should you wish us to do so and your application is suitable for entry to the Engineering Academy.

Please note: once the application has been transferred over, you will no longer be considered for entry to the original course choice.

3. If you have already submitted a UCAS application to the University of Strathclyde but not an Engineering course:

Again, we can arrange for your application to be transferred over to the BEng Engineering Academy admissions code should you wish us to do so and your application is suitable for entry to the Engineering Academy.

Please note: once the application has been transferred over, you will no longer be considered for entry to the original course choice.

4. If you have already submitted a UCAS application and have been unsuccessful in all of your original choices:

You can utilise UCAS Extra. Details of when this opens can be found on the UCAS key dates website. UCAS Extra can only be used where an applicant is not holding any offers. Therefore, if you submitted a UCAS application and have been unsuccessful in all of your original choices, you can apply to the BEng Engineering Academy as your 'Extra' choice. 5. If you have already submitted a UCAS application and have been made offer(s) from any of your original choices and still wish to be considered for entry to the BEng Engineering Academy:

UCAS Extra can only be used where an applicant is not holding offers. Therefore, if you receive one or more offers from your original choice(s) and still wish to be considered by the Engineering Academy, you will be required to decline the offers.
