Worrying About Money? ERCAB are here to help!

Financial advice and support is available if you're struggling to make ends meet.

There are a number of options available to clients who are struggling;

- Scottish Welfare Fund people on low incomes may be able to get a crisis grant from the Council. This is a payment to help you cope during an emergency or due to unexpected expenses.
- Maximise your income a benefit check can be carried out by one of our experienced advisers to make sure you're not missing out on any money you may be entitled to. Speaking to an adviser may also help you find cheaper deals on gas and electricity.
- Debt Advice debt can happen to anyone. Free advice and support can help you find ways to manage your debts and reduce how much you pay each month. Contact our Money Adviser, Julie on 07901607309.
- 4. Benefit Advance if you have made a new claim for benefits and are in financial hardship while you wait for your first payment, you may be able to get an advance to afford things like food or rent.
- 5. Hardship Payment if you have been sanctioned, you may be able to request a hardship payment from the Jobcentre.
- Challenge a Decision you can challenge a decision if your benefit has been stopped/sanctioned/overpaid etc. Most benefit decisions need to be challenged within one month.

Help With Housing and Heating Benefits

- Apply for a Discretionary Housing Payment you may be eligible for this if you are in receipt of housing benefit but still can't afford housing costs.
- Claim Housing Benefit you could get housing benefit to help you pay your rent if you're on low income.
- Get help with energy bills ERCAB's energy and utilities Adviser, Mark P may be able to help you keep a warm and comfortable home.
- Local Housing Allowance information on how to apply for housing benefit if you're renting privately.
