Case Study - Benefits

Our client's daughter contacted ERCAB as her father had passed away. Her mother wished advice on how to deal with his Estate, private & state pension & to register his death. They attended ERCAB together to receive advice.

An adviser offered 1st level advice and guidance on all of these matters, referred them to their preferred family solicitor to assist with legal matters and contacted the private pension provider & The Pension Service (DWP) to advise of his death. Client was also referred to ERC to register the death & obtain a death certificate; which would be required to progress his Estate.

A benefit check was carried out and established eligibility for Attendance Allowance (AA). We contacted the DWP Helpline to register the claim & initiate an application form. Our adviser then explained the benefit, process & suggested supporting evidence to bring with her to her next appointment for completion of the AA application form.

Client contacted the bureau this week to advise that their Attendance Allowance application has been successful and she has been awarded the Higher payment of £92.40 per week and a backdated payment of £739.20.

Our client is absolutely thrilled and delighted with our assistance as she had no idea such a benefit existed. The next step, now client is in receipt of AA is assisting our client with a Council Tax Reduction application and Blue Badge application.

Social Security Scotland -

The Best Start School Age Payment application window for 2022-2023 is closing for new applications on 28th February.

This is a one-off payment of £267.65 aimed towards assisting families in the cost of their child starting their first year of primary school.

You can apply at online, by phone, in person or by post. Please note if you already get Scottish Child Payment for an eligible child then you should get this payment automatically (unless previously opted out of automatic payments).

Good News Story - PIP/ADP

A client with fibromyalgia and mental health issues approached the bureau in September 2021 for assistance making a PIP application. The original form, mandatory reconsideration and appeal were all unsuccessful in securing an award.

The client was then advised to make an Adult Disability Payment (ADP) application in September 2022.

This application was successful in securing the client an award of enhanced DLC and enhanced MOB for five years. This total award represents a client financial gain of £40,794.00.
