The school is non-denominational and co-educational.

Children in the age range 4 – 12 are accommodated in Primary 1 – 7 classes.

## Playground Supervision

An adult presence is provided in playgrounds at all break times in terms of the Schools (Safety and Supervision of Pupils) (Scotland) Regulations 1990. There is adult supervision in the playground from 8.45am and in the event of extreme weather this supervision is moved inside and children are allowed indoors. However, please note that children are not allowed into the school until the supervision is in place.

## Attendance

Parents have a legal duty to make sure that their children attend school. But as well as this, children need to attend school to get the best out of their education.

The school records attendance twice a day (once in the morning and again in the afternoon). Parents must let the school know about any absence which could include sickness, religious observance or bereavement among others as early as possible by contacting the school office. This way we can keep accurate attendance records.

Also, you should avoid taking time off for holidays during term-time. Even towards the end of term when you may think there's not much 'school work' going on, there are lessons and activities for all pupils which are an important part of their education.

## School admission arrangements

Before a child enrolls in Kirkhill Primary School, the Education Department will seek documentary evidence to validate a child's entitlement to a catchment place at this school. If appropriate evidence is not submitted the Education Department will withdraw the offer of a place. Documentary evidence can be submitted to the Education Department via the school office. Further detail on required documentary evidence and change of circumstances is available in the Education Department's school admission policy which is accessible on the Council's website via the web address below:

When a child who was enrolled in the school as a catchment pupil ceases to reside within the Kirkhill Primary delineated catchment area and his/her parents wish the child to continue to attend the school the parent must submit a placing request to remain. Where it is found that a child is no longer entitled to a catchment place in Kirkhill Primary since they no longer reside in a property in the delineated catchment area associated with the school, and a placing request to remain has not been submitted and approved, the Council may seek to exclude that child from the school.

A child's parents(s)/carer(s) is/are responsible for providing the Education Department with full and correct information about their child(ren) and any changes to that information which may affect their status as a catchment child. In the event that parent(s)/carer(s) fail to do this, the Education Department will view this as a refusal to comply with the rules and regulations of the school; this lack of cooperation will result in the Council seeking to exclude the child(ren) from Kirkhill Primary School.

If information that is submitted is found to be fraudulent the Council may pass the matter to the Procurator Fiscal's Office. The Council will use all means available to it in order to investigate suspicions or allegations of fraud, including but not limited to, surveillance in cases where it is necessary and proportionate to do so.

## Introduction

In Kirkhill, all children are entitled to experience a broad general education. Through careful planning our staff will ensure that each learner experiences the highest possible standards and are able to be successful learners, confident individuals, responsible citizens and effective contributors to society.

## Curriculum

In general, in enrolling a child at this school a parent accepts that the child will receive the curriculum offered, which meets the national guidelines.

This means that, with very limited exception, pupils cannot be withdrawn from particular subjects/parts of the curriculum or specific activities forming part of the curriculum at the school.

The limited exceptions, when a pupil may be withdrawn by parental request, exist in relation to (i) religious observance and instruction and (ii) sex education programmes. Other than these two excepted areas however, pupils are required to participate in all parts of the approved curriculum.

Parents may wish to note that in the event of the school seeking to make major changes to the curriculum on offer, consultation will be carried out with them and other stakeholders through the Parent Council and by other appropriate means.

## Literacy and English

The development of Literacy and English language skills plays an important role in all learning.

Our pupils develop and extend their literacy and English language skills when they have opportunities to


- communicate, collaborate and build relationships
- reflect on and explain their literacy and thinking skills, using feedback to help them improve and sensitively provide useful feedback to others
- engage with and create a wide range of texts in different media, taking advantage of the opportunities offered by ICT
- develop their understanding of what is special, vibrant and valuable about their own and other cultures and their languages
- explore the richness and diversity of language, how it can affect them, and the wide range of ways in which they and others can be creative
- extend and enrich their vocabulary through listening, talking, watching and reading
- engage with a wide range of texts and are developing an appreciation of the richness and breadth of Scotland's literacy and linguistic heritage
- enjoy exploring and discussing word patterns and text structures



## Numeracy and Mathematics

Our pupils' learning in Mathematics enables them to:

- develop a secure understanding of the concepts, principles and processes of mathematics and apply these in different contexts, including the world of work
- engage with more abstract mathematical concepts and develop important new kinds of thinking
- understand the application of mathematics, its impact on their society past and present, and its potential for the future
- develop essential numeracy skills which will allow them to participate fully in society
- establish firm foundations for further specialist learning
- understand that successful independent living requires financial awareness, effective money management, using schedules and other related skills
- interpret numerical information appropriately and use it to draw conclusions, assess risk, and make reasoned evaluations and informed decisions
- apply skills and understanding creatively and logically to solve problems, within a variety of contexts
- appreciate how the imaginative and effective use of technologies can enhance the development of skills and concepts



## Health and Wellbeing

Learning in Health and Wellbeing ensures that children and young people develop the knowledge and understanding, skills, capabilities and attributes which they need for mental, emotional, social and physical wellbeing now and in the future.

Kirkhill, working with partners, takes a holistic approach to promoting health and wellbeing. Our pupils can expect their learning environment to support them to:

- develop their self-awareness, self-worth and respect for others
- meet challenges, manage change and build relationships
- experience personal achievement and build their resilience and confidence
- understand and develop their physical, mental and spiritual wellbeing and social skills

- understand how and what they eat, how active they are and how decisions they make about their behaviour and relationships affect their physical and mental wellbeing
- participate in a wide range of activities which promote a healthy lifestyle
- understand that adults in their school community have a responsibility to look after them, listen to their concerns and involve others where necessary learn about where to find help and resources to inform choices
- assess and manage risk and understand the impact of risk-taking behaviour
- reflect on their strengths and skills to help them make informed choices when planning their next steps
- acknowledge diversity and understand that it is everyone's responsibility to challenge discrimination



Prior to teaching sensitive aspects of health and wellbeing, such as relationships, sexual health and parenthood, parents and carers will be invited to an information evening at the school. They will have the opportunity to learn how these issues are tackled in the school and chat to staff about how they can be involved at home.

## Religious and Moral Education

In Kirkhill, learning through Religious and Moral Education enables our children to:

- recognise religion as an important expression of human experience
- learn about and from the beliefs, values, practices and traditions of Christianity and the world religions selected for study, other traditions and viewpoints independent of religious belief
- explore and establish values such as wisdom, justice, compassion and integrity and engage in the development of and reflection upon moral values
- develop their beliefs, attitudes, values and practices through reflection, discovery and critical evaluation
- develop the skills of reflection, discernment, critical thinking and deciding how to act when making moral decisions
- make a positive difference to the world by putting their beliefs and values into action
- establish a firm foundation for lifelong learning, further learning and adult life



## Social Studies

Learning about Social Studies in Kirkhill, will enable our pupils to:

- develop their understanding of the history, heritage and culture of Scotland, and an appreciation of their local and national heritage within the world
- broaden their understanding of the world by learning about human activities and achievements in the past and present
- develop the understanding, of their own values, beliefs and cultures and those of others
- develop understanding of the principles of democracy and citizenship through experience of critical and independent thinking
- explore and evaluate different types of sources and evidence
- learn how to locate, explore and link features and places locally and further afield
- engage in activities which encourage enterprising attitudes
- develop an understanding of concepts that stimulate enterprise and influence business
- establish firm foundations for lifelong learning and for further specialized study and careers



## Expressive Arts

In Kirkhill, experiences in the Expressive Arts involve creating and presenting and are practical and experiential. Evaluating and appreciating are used to enhance enjoyment and develop knowledge and understanding.

Our pupils learning in, through and about the expressive arts:

- enables them to experience the inspiration and power of the arts
- recognises and nurtures their creative and aesthetic talents
- allows them to develop skills and techniques that are relevant to specific art forms and across the four capacities
- provides opportunities for them to deepen their understanding of culture in Scotland and the wider world
- is enhanced and enriched through partnerships with professional arts companies, creative adults and cultural organisations

## Sciences

In Kirkhill, learning about the Sciences will enable our pupils to:


- develop curiosity and understanding of the environment and their place in the living, material and physical world
- demonstrate a secure knowledge and understanding of the big ideas and concepts of the sciences
- develop skills for learning, life and work
- develop the skills of scientific enquiry and investigation using practical techniques
- develop skills in the accurate use of scientific language, formulae and equations
- apply safety measures and take necessary actions to control risk and hazards
- recognise the impact the sciences make on their life, the lives of others, the environment and on society
- recognise the role of creativity and inventiveness in the development of the sciences
- develop an understanding of the Earth's resources and need for responsible use of them
- express opinions and make decisions on social, moral, ethical, economic and environmental issues based upon sound understanding
- develop as a scientifically-literate citizen with a lifelong interest in the science
- establish the foundation for more advanced learning and future careers in the sciences and the technologies



## Technologies

In Kirkhill, learning about the Technologies enables our pupils to:

- develop an understanding of the role and impact of technologies in changing and influencing societies
- contribute to building a better world by taking responsible, ethical actions to improve their life, the lives of others and the environment
- gain the confidences and skills to embrace and use technologies now and in the future, at home, at work and in the wider community
- be capable of making reasoned choices relating to the environment, sustainable development and ethical, economic and cultural issues
- broaden their understanding of the role that information and communication technology (ICT) has in Scotland and the global community.



It is important that as our children play and learn they will develop an interest, confidence and enjoyment in ICT skills that can be transferred and applied in different learning contexts.

## Modern Languages

Learning a new language encourages children and young people to broaden their horizons as they explore the language and its associated culture.

In Kirkhill, our pupils learn French from P1 - P7 and Mandarin from P5 – P7.

In doing so:

- they gain a deeper understanding of their first language and appreciate the richness and interconnected nature of languages
- they enhance their understanding and enjoyment of other cultures and of their own and gain insights into other ways of thinking and other views of the world
- develop skills that they can use and enjoy in work and leisure throughout their life

## Other Learning Opportunities

Throughout their time at Kirkhill, pupils will be offered many different cross curricular learning opportunities. These can take the form of outdoor learning in the school playground and surrounding area, school trips to support class topics and visits from outside agencies. These will be detailed on the Curriculum Newsletter issued to parents and carers each term.



A visit to an outdoor centre is planned for Primary 7 every year where the classes involved are afforded the opportunity to participate in a diverse range of outdoor activities. These vary depending on the time of year but can include abseiling, orienteering, and kayaking.



## Religious Education Withdrawal

Parents have a legal right to withdraw their children from religious education and observance (Section 8, Education Act 1980) and this can be put into effect by notifying the school of their decision.

## Assessment and Reporting

We have a structured programme of continuous assessment of pupils. These assessments help the school to provide greater challenges to the children who require it and also to put in place extra support whenever a child needs it. We will also use assessment information to provide greater challenges to the children who require it and also to put in place extra support whenever a child needs it. Standardised testing is used in P1, P3, P5 and P7. These results are used by staff to help plan the next stages in learning and teaching.

Assessment information is also used to provide end of year reports to parents and for discussion during our twice-yearly parents meetings.

## Scottish National Standardised Assessments (SNSA)

As part of the Scottish Government's National Improvement Framework, all children in P1, P4 and P7 will complete a set of national standardised assessments (SNSAs). Currently, these assessments are in addition to East Renfrewshire's standardised assessments at P1, P3, P5 and P7.

These assessments will add to the ongoing assessment profile that class teachers are able to build up over the course of a session. They aim to provide an additional source of nationally consistent evidence for teachers to use when assessing children's progress. As always, teachers will continue to draw on all of the assessment information available to them when considering children's progress and planning for their next steps in learning.

The SNSAs focus on aspects of reading, writing and numeracy. Children in P1 will undertake 2 assessments (literacy and numeracy) while children in P4 and P7 will undertake 3 (reading, writing and numeracy).

Children do not need to revise or prepare for SNSAs and they will form part of children's daily routine. Assessments will be completed digitally and will be automatically marked online. Each assessment is designed to last a maximum of 45 minutes, although it is unlikely that children will require this full time. The system is designed so that if a child starts to experience difficulty, the questions will get easier. If a child appears to be doing well, the questions will get more challenging. In this way it is believed that the most



accurate picture of a child's progress can be determined. Children are not expected to undertake more than one assessment on any particular occasion.

The online assessment system provides feedback information which teachers will use, along with a wide range of assessment information, to discuss your child's progress in learning. This will usually happen through existing channels of communication, such as parent consultation evenings and summative report cards. Education Scotland is also currently working with teachers and parents to develop guidance on the best ways to report on children's progress.

As the SNSAs should be seen by your child as just another aspect of daily learning, there is no need for parents to prepare their child or practise any specific tasks or activities.

The online assessment system provides feedback information which teachers will use, along with a wide range of assessment information, to discuss your child's progress in learning. This will usually happen through existing channels of communication, such as parent consultation evenings and summative report cards.

The SNSAs can take place at any point during the course of a school session. Usually the children will undertake the assessments during the summer term (April-May) class teachers and the Leadership Team will judge when best to incorporate them into children's daily routine.

## Celebrating Achievements

Throughout the year there will be opportunities for parents and carers to see pupils' work and find out more about their learning and areas for improvement. The Seesaw app and Twitter (@KirkhillPS) will share achievements, learning and information to support our pupils and will provide an insight into the classroom. A Curriculum Overview is also sent home detailing the learning to be undertaken by every child each term.

There are open days throughout the year when parents and carers are invited into their child's class.

Our learners are successful, confident, exercise responsibility and contribute to the life of the school, the wider community and as global citizens. Our pupils achieve a range of skills and attributes through a wide range of activities.

As a school, we are committed to recognising a broad sense of achievement. Therefore, in addition to the many ways in which we celebrate achievement within school already we would like you to inform us of any additional achievements that we may not yet know about your child.



## Additional Support Needs

All East Renfrewshire schools use the Staged Intervention framework to assess additional support needs and systematically review and refine those plans to ensure the best outcomes for pupils. This has been designed to allow school staff, partner agencies, pupils and parents to be active participants in the plan. Your child's teacher will discuss the strategies agreed to help support your child, and will welcome your views and any suggestions you might have. The very important review process, when the success of the agreed strategies is discussed is also an area where your views will be sought.



The school's ASN Co-ordinator, Miss Cumming is responsible for assuring the whole school approach and bringing together the various facets of pupil support including pastoral, behaviour and learning.

Class teachers are responsible for the delivery of education and are therefore central to the effective implementation of Staged Intervention at all levels.

Class teachers may be supported by pupil support staff (PSAs, ASN teacher, Stage Managers) to deliver, monitor and review the strategies and actions as detailed in the Child's Wellbeing Plan.

Other agencies working with the school may include Family Learning, Outreach, Request for Assistance, Speech and Language Therapist, School Nurse. When involved, their roles and responsibilities will be stated within the Child Wellbeing Plan.

If you would like to discuss any aspect of your child's wellbeing plan further, please call and arrange a meeting with Miss Cumming, Additional Support Needs Co-ordinator.

## Stage Leaders

Stage Leaders may at times be used to provide pastoral care and support for pupils and their families within their stages. If you wish to speak to a member of the leadership team regarding your child's welfare or for curricular support they will happily pass on the information to the class teacher.

## School Travel

### Transport

The Education Authority has a policy of providing free school transport to all primary pupils who live more than two miles from their catchment school by the recognised shortest walking route. This policy is more generous than the law requires. This means that the provision of transport could be revised at any time. Parents who consider that they are eligible should obtain an application form from the school or council offices.

These forms should be completed and returned before the end of February for those pupils beginning school in August to enable the appropriate arrangements to be made. Applications may be submitted at any time throughout the year, but may be subject to delay while arrangements are made.

Where there are vacant seats on a dedicated school vehicle these can be offered as privileged places to pupils not eligible for free school transport. There is a charge for this and full details and an application form can be obtained from the Education Department Offices, Main Street, Barrhead (0141 577 3258/3279). These places are normally allocated in September once it has been established if there are any seats available. Should there be more applications than places available a ballot will take place.

### Pick up Points

Where free transport is provided, it may be necessary to walk a certain distance from home to the pick-up point and from the drop-off point to the school in any one direction. This distance will not exceed the authority's limits (see paragraph 1 above). It is a parent's responsibility to ensure their child behaves in a safe and acceptable manner while boarding, travelling in and alighting from the vehicle. Misbehaviour could result in your child losing the right to free transport. Children are normally transported to and from school to allow arrival before 9.00 am and return after 3.00 pm.

## Admissions

Before a child enrolls in Kirkhill Primary School, the Education Department will seek documentary evidence to validate a child's entitlement to a catchment place at this school. If appropriate evidence is not submitted the Education Department will withdraw the offer of a place. Documentary evidence can be submitted to the Education Department via the school office. Further detail on required documentary evidence and change of circumstances is available in the Education Department's school admission policy which is accessible on the Council's website via the web address below:

When a child who was enrolled in the school as a catchment pupil ceases to reside within the Kirkhill Primary delineated catchment area and his/her parents wish the child to continue to attend the school the parent must submit a placing request to remain.

Where it is found that a child is no longer entitled to a catchment place in Kirkhill Primary since they no longer reside in a property in the delineated catchment area associated with the school, and a placing request to remain has not been submitted and approved, the Council may seek to exclude that child from the school.

A child's parents(s)/carer(s) is/are responsible for providing the Education Department with full and correct information about their child(ren) and any changes to that information which may affect their status as a catchment child. In the event that parent(s)/carer(s) fail to do this, the Education Department will view this as a refusal to comply with the rules and regulations of the school; this lack of cooperation will result in the Council seeking to exclude the child(ren) from Kirkhill Primary School.



If information that is submitted is found to be fraudulent the Council may pass the matter to the Procurator Fiscal's Office. The Council will use all means available to it in order to investigate suspicions or allegations of fraud, including but not limited to, surveillance in cases where it is necessary and proportionate to do so.



## School Lunches

At Kirkhill we use a 'Cashless' catering service, i.e. your child pays for their lunch using an allocated Pin number. This pin number is unique to your child. We encourage parents/carers to make payment on line via the Payment4schools website or by following the link on the Kirkhill website. Pupils in receipt of free school meals will automatically receive credit each day but only when they are in attendance at school. Please note all P1-P3 pupils are entitled to free school meals.

For all pupils, the lunch room operates a choice of snack and main meals, and either a starter or dessert. All foods are freshly prepared each day. The menu varies from day to day and week to week. A copy of the menu is posted on the council website, with a link from the school website.

We aim to have a healthy eating approach. If the school catering staff has prior notification, any child needing a special diet can be catered for. Children who bring packed lunches are also accommodated in the dining room and gym hall. In Kirkhill, the eating of lunch is a social occasion where staff and children meet in a less formal setting. We ask that parents support this policy by encouraging good table manners and eating habits at home.

Children of parents receiving income support or job seeker's allowance (income based) are entitled to a lunch without charge. Information and application forms for free school lunches may be obtained from the school, education department and area offices.

**Please note that Kirkhill Primary is a nut free school and we would ask parents/ carers to support us in this. Should any child bring in a snack from home that does contain nuts, it will be removed and a suitable alternative will be offered in its place.**

## Child Protection: Keeping our Children Safe and Well

At Kirkhill Primary we work hard to keep our children safe. We take care, welfare and protection of our children very seriously. We believe all children have a right to feel safe within school, home and community.

With our school we strive to provide a safe, secure and nurturing environment for our pupils, which promotes inclusion and achievement. All staff in Education have a statutory and professional responsibility to take action if we have reason to believe a child is suffering, or is at risk of abuse.

Our child protection policy and procedure sets out what we will do if we have reason to believe a child is being abused or is at risk of abuse, either within the home or the community. These policies are designed to ensure that children get the help they need when they need it.

Every staff member undergoes a minimum of one child protection training activity every session. Many of our staff are more extensively trained in specific areas of child protection to support and identify potential child protection concerns.

All school in East Renfrewshire have comprehensive Pupil Support systems in place and we work closely with our partners in Social Work, Health and the Police. The school operates a multi-agency Joint Support Team to ensure that the best possible supports are available to pupils when they need them.

It's difficult to know how to effectively manage challenging behaviours and achieve a happier, more positive relationship with your child.

PoPP provides positive parenting programmes to help you manage the challenging behaviours and enjoy being a parent. The parenting programmes come in the form of weekly groups for parents to look at ways of helping their child manage emotions and behaviour. The school building is fitted with a secured entry system – the door can only be opened from indoors. It is only as safe as the people who use it. All visitors should press the buzzer at the office at the main entrance, where you will be directed appropriately. Parents dropping off or collecting children from school after 9 a.m. and 3 p.m. should do so via our main entrance. They should follow as directed below: To enter, press the buzzer, and do not let any unknown person in with you; they should go to the school office for entry. Make sure the door is closed firmly behind you. An adult presence is provided in playgrounds at break times in terms of the Schools (Safety and Supervision of Pupils) (Scotland) Regulations 1990. At Kirkhill our janitor and support staff supervise our playground, both at interval and lunchtime. From time to time a decision is made for your children to have their break indoors. Primary 7 buddies, support staff and senior management team supervise the children during this time.
