# **Government Funded Free Meal Entitlement & Clothing Grants**

## Why should I sign-up?

**The Scottish Government's "Pupil Equity Funding" means that we can access funding to support your child in school.**

-  If you meet the conditions then you are allowed additional benefits, which would be either for clothing and/or free school meals.
-  If your child is in P1 – P3 and will receive free school meals anyway, it is still important that you sign up so that you can apply year on year after they have left P3.
-  The current school funding formula, implemented by the Scottish Government is allocated against the number of children registered for FME. If families who are entitled to this benefit do not register for it then it is possible that the school will also be missing out on the allocation of funds.

## Do I Qualify for Free School Meal Entitlement and/or Clothing Grants?



You can apply if your child attends an East Renfrewshire primary school or secondary school. You also need to receive a qualifying benefit. The grid below outlines the benefit(s) that are eligible.

## Proof of Qualifying Benefits

### Proof of qualifying benefits



#### Employment and Support Allowance (income related)

-  ERC residents - we'll automatically check our benefits system.
-  Non ERC residents - provide your current award letter.



#### Income Support

-  ERC residents - we'll automatically check our benefits system
-  Non ERC residents - provide your current award letter.


#### Job Seekers Allowance (income based)

-  ERC residents - we'll automatically check our benefits system
-  Non ERC residents - provide your current award letter.



#### Child Tax Credit and Working Tax Credit

-  2017/18 Tax Credit award letter showing 2016/17 assessed income.
-  Annual review award notice for yourself and your partner (where applicable) showing your total household income. You must also provide your P60.



#### Support under part VI of the Immigration and Asylum Act

-  Recent confirmation letter from Home Office. This must be no more than 3 months old.

#### Housing benefit

-  ERC residents - we'll automatically check our benefits system.
-  Non ERC residents - provide your current award letter.

#### Universal credit

-  ERC residents - we'll automatically check our benefits system.
-  Non ERC residents - provide your current award letter.

In addition to the funding you receive, the government are offering schools financial support per eligible child. Substantial opportunities and resources can be accessed with this.

## What happens next?

After you apply:

-  Payment of £75 per child will normally be made to your bank account within 15 working days of receipt of your application. This applies to applications with full and correct information
-  If you are entitled to free school meals we will notify the school. We will not write to you separately to confirm this.
-  If you have made a placing request or your child is entering P1 or S1 payment will be made when your child's details have been verified by the school.
-  If your child is entitled to leave school a clothing grant will not be paid until confirmation has been received from school that they have returned after the summer break.
