



Broomhill Primary Home-School Agreement School

- ✓ We will reopen for staff in-service on Monday 10 and Tuesday 11 August.
- ✓ Children will return to school full-time from Wednesday 12 August.
- ✓ We will focus on reconnection with and among pupils, and support them make the transition back to school following COVID-19 closure.
- ✓ We require children to distance themselves from adults but not other children.
- ✓ We will stagger starting times and home times to reduce contact between adults.
- ✓ We will rota playtimes and lunchtimes to ease adult numbers in the playground staffroom and dining hall. Year groups will be outside together.
- ✓ We will implement current hygiene, infection control and adult distancing guidance to help keep everyone safe. There will be an enhanced daily cleaning schedule.
- ✓ As a nurturing school, compassion, care and wellbeing will be central to our work in delivering inclusive and equitable quality education across the curriculum.
- ✓ We will ensure children's health and wellbeing, literacy and numeracy are at the heart of our assessment and planning.
- ✓ We will listen and respond to children's and staffs' experiences of Covid-19.
- ✓ We will provide targeted additional support where necessary to address gaps in learning and to continue to close the poverty-related attainment gap.
- ✓ We will initially deliver PE outdoors, weather permitting.
- ✓ We will allocate additional time for outdoor play.
- ✓ We will provide clear and timely information for families.
- ✓ We will continue to consult with children and parents to inform our recovery plans.
- ✓ We will ensure recovery arrangements, including risk assessments and procedures, are regularly updated to take account of national guidance and are available on our website.
- ✓ We will respond to parent queries by phone and email. For the time being any necessary meetings will be by appointment and require social distancing and hygiene measures.

This Home-School Agreement sets out the expectations of the school community from 12 August 2020. Children and parents are not required to sign this document.

Child/Young Person

I will do my best to follow these important school rules:

- ✓ **I will stay a 2 metre safe distance from teachers and other adults.**
- ✓ **I will clean my hands regularly throughout the day with soap and water for 20 seconds, or hand sanitiser. I will wash my hands when I enter/exit school, before and after playtime and lunchtime, and after toilet use.**
- ✓ **I will tell an adult straight away if I feel unwell or worried or need help.**
- ✓ **I will only bring the following belongings from home into school - my indoor shoes (P2-7 only), school bag, lunch box, filled water bottle, snacks and homework.**
- ✓ **I will play and work in the areas I am allocated by staff.**
- ✓ **I will use the door routes and areas assigned to my class.**
- ✓ **I will let an adult know when I need to go to the toilet.**
- ✓ **I will use the 'catch it-bin it' rule (coughing and sneezing into my elbow or a tissue).**
- ✓ **I will complete my homework tasks to the best of my ability.**
- ✓ **I will bring my Broomhill iPad to class, fully charged (Primary 7s only).**
- ✓ **I will be guided by the school's 5 shared values – teamwork, kindness, respect, aspiration and integrity.**



Parent/Carer

I will support the following school recovery measures:

- ✓ I will drop-off and pick-up my child from school at the allocated time.
- ✓ I will ensure only one adult accompanies my child to school to reduce contact at the gate.
- ✓ I will maintain a safe distance from others at school drop-off/pick-up times.
- ✓ I will only drive to school by car when necessary – at all other times my child and I will travel by foot, wheel or cycle.
- ✓ I will ensure my child brings the following items to school:
 - a filled water bottle, labelled with my child's name
 - snacks and lunch items that my child can independently open
 - indoor shoes for class
 - suitable footwear for outdoor gym lessons
 - their homework folder with workbooks
 - school iPad, fully charged (Primary 7s only).
- ✓ I will ensure my child's items are clearly labelled, including uniform and footwear.
- ✓ I will support my child to engage with their homework.
- ✓ I will alert the school as soon as practical if/when my child/family member: tests positive for COVID-19; displays symptoms of COVID-19; or has been advised to self-isolate in line with Government guidance.
- ✓ I will email or leave a phone message for the headteacher, depute or Parent Council if I have a question or concern, as I understand that the staff will be working with children during class time and breaks, and unavailable for calls or emails during these times.
- ✓ I will help my child prepare for and manage the new school arrangements.
