

#### P5&P6 Pupil iPad Contract

Dear Parents/Carers

In Primary 5 and Primary 6 as part of our Connected Learning digital rollout programme, your child will receive their own iPad and charger to use for learning purposes in school and at home.

In order for us to arrange, set up and distribute the iPads we require children and families to read and sign a contract. The contract explains the expectations for using the iPad. In order for your child to receive an iPad they are required to read, sign and return the contract to their class teacher by **Thursday the 13<sup>th</sup> of October**. If they do not return the contract by this date then they may not receive their iPad at the same time as the rest of the cohort.

Unlike the current Primary 7 iPads, pupils will not take home the iPads initially. Primary 5 pupils will keep their iPads in school most of the time. For the first few months, Primary 6 will keep their iPads in school but in the last few they terms they may have the opportunity to take them home to prepare for Primary 7.

The iPad provided belongs to Glasgow City Council and is traceable through the Council's Mobile Device Management system. All parties involved (pupils, parents/carers and the school) must agree with all of the terms and conditions outlined below.

If any of these expectations are not met then the school reserves the right to restrict or remove access to any school ICT facility as in line with the Pupil Acceptable Use Policy.

#### As a pupil, I agree to:

- Look after my iPad carefully at all times and always store my iPad in its supplied case and store it in an appropriate place such as a charging station or school bag when outside my class.
- Immediately report any technical problems, damage, loss or theft to **your class teacher**.
- Ensure that the iPad is charged up in school in the charging station. Should I have the opportunity to take the iPad home I will ensure that I charge my iPad and bring both the iPad and the supplied charger into school unless told otherwise. iPads should be charged to an appropriate level at the start of each day so that it can be used within lessons.
- Only take my iPad out in class or in a secure environment such as my home. Never take my iPad out in the playground, when walking between classes or when travelling to and from school unless directed to do so by a member of staff.
- Only use my iPad in lessons when instructed to by my teacher and close it or put it away when my teacher says so. Only use apps and websites on my iPad that my teacher has agreed I can use in the lesson.
- Never share my pin code with **anyone.** If I suspect someone knows my code then I will inform a teacher who can reset it.
- Present my iPad for a check whenever I am asked to do so by a member of staff. If I have forgotten my iPad I must bring it in the next day to show it hasn't been lost or stolen. Failure to do so will result in a communication home.
- Only use my iPad to take photos, record audio or video clips for learning purposes with the knowledge and agreement of everyone involved, this includes children and adults.
- Only share and Airdrop content with others when explicitly asked to do so by a member of staff. If I receive content that is unexpected then I will report it immediately to an adult.
- Never access inappropriate content on my iPad or attempt to bypass any of the security features. This includes illegal sites that allow streaming of music, videos and movies.
- Never remove any asset tags or security markings from my iPad.

- Not graffiti the iPad this includes drawings and stickers on the case.
- Ensure that all work stored on the iPad is regularly backed up to the iCloud.

The school will not be responsible for any costs involved, nor content accessed, when the internet is used out of school.
- Do regular checks on the condition of the iPads. If an iPad has been forgotten, this will be recorded.
- Issue questionnaires to pupils and parents/carers to help us in the ongoing evaluation of the iPads.
