Answers to digital questions during meeting from Sophie Lamont

Are Showbie and other apps linked to pupil's school or personal email accounts? Seems to be an issue with a pupil who seems to have to use his personal email for schoolwork.

Students can link them to their Showbie account, but they do not have to. If they want to, they go to their icon, edit details, and can enter an email there. Alternatively, their teacher can do this for them.

Comment in chat box from parent – “who keeps an eye on the chat function on ipads because from what I've seen and heard a lot of the kids are just messing about on it”

I'm not sure what 'chat function' is being discussed here. Students can obviously communicate on Teams/Showbie but this would be monitored by their teacher. They also could email each other which is not routinely checked, but if a student is concerned about email, they receive this can be looked into.

Concerns raised over all pupils in S1-S4 having the same generic password and whether it breaches data protection or security. According to one parent Rosshall is the only school using the same password for the S1-S4 group.

Discussed with AM and GCC. AM has sent reply.

A parent raised the issue of her child (S4) not having received any notification/invitation to the recent digital evening and was disappointed she hadn't been able to attend as she knew nothing about it.

The invitation was sent to all year groups via Glow and discussed in personal support to try our best and get the message out. Students should check they are in their year group's glow group, if not they can be added. They should also check they do not have the 'focussed inbox' on as this can sometimes filter emails unintentionally. A guide to doing this has been in the Getting to Know your iPad lessons.

Answer to generic password question

We have looked into the lock code issue with the other schools Sophie was liaising with and GCC (Nicola Rossiter). While it does not directly contravene GDPR guidelines, it is not advised and we have collectively found a better solution, agreed by GCC, that pupils change their passcodes to their DOB to allow pupils to feel more protected and mitigate others accessing their i-Pad.

We will roll out that pupils all change their passcodes to their DOB. This means that teachers can access i-Pads if necessary, using information from SEEMIS and pupils will feel secure in the knowledge that their passcode is specific to them. We will aim to do this in Personal Support as soon as possible.
