### **Statutory Consultation Proposal: Cullen Catchment Area Secondary School Rezoning Proposal**

Moray Council is consulting on varying the catchment areas of Keith Grammar School and Buckie High School. The proposed amendments will affect only a small number of families.

There is a period of Statutory Consultation for this proposal which will run from **Wednesday 1st February – Friday 17th March 2017**. This allows for 31 school days within the consultation period, which meets the statutory requirements.

The consultation proposal document will be made available at Moray Council Headquarters Access Point (Elgin), Keith Grammar School, Buckie High School and Cullen Primary School, Cullen Library and on the Council web site.
