

FREE SCHOOL MEALS AND CLOTHING GRANTS



DO YOU QUALIFY?

If you are in receipt of :

- Housing Benefit
- Council Tax Rebate
- Income Support
- Job Seekers Allowance (Income based)
- ESA (Income based)
- Child Tax Credit (Income below £16,105) with no element of working tax credit
- Maximum and Working Tax Credit (Income below £6,420)
- Support Under V1 of the Immigration and Asylum Act (1999)
- Universal Credit (Maximum Monthly Income £610)

If you think you qualify, complete a form making sure the benefit received is clearly identified and relevant documents are enclosed. No documents are required if you are in receipt of housing/council tax benefit. Contact the school if you are in any doubt or want to check if you are entitled to claim in the strictest confidence. Help can be provided to complete the application.

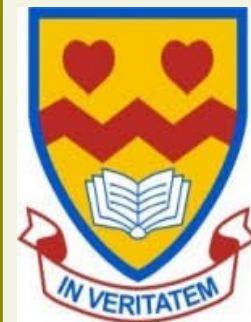
