



## **New Monkland Nursery Class**

### **Duty of Candour Report January 2026**

All health and social care services in Scotland have a duty of candour. This is a legal requirement which means that when things go wrong and mistakes happen, the people affected understand what has happened, receive an apology, and that organisations learn how to improve for the future.

An important part of this duty is that we provide an annual report about the duty of candour in our services. This short report describes how New Monkland Nursery Class has operated the duty of candour during the time between January 2024 and January 2025. We hope you find this report useful.

#### **About New Monkland Nursery Class**

New Monkland Nursery is in the same building as the Primary school. Our Nursery facility is regulated by the Care Inspectorate who last inspected us in April 2025 and Her Majesty's Inspectors in Education inspected us in October 2018. Our numbers were increased to 44 from 32 as of August 2024 and we are a full day, term time nursery for children who are between 3 and 5 years of age. Our children come for 1140 hours of funded nursery learning per year which is delivered by our dedicated staff team.

#### **How many incidents happened to which the duty of candour applies?**

In the last year, there have been no incidents to which the duty of candour applied. There have been no unintended or unexpected incidents where the level of seriousness has linked directly to the Duty of Candour legislation. As ever, should the need arise, we will openly admit the error and apologise to the individual and their parent or carer. We

endeavour to be truthful in all our dealings with you as service users and we will continue to do our best to mitigate any potential harm.

### **To what extent did New Monkland Nursery Class follow the duty of candour procedure?**

New Monkland Nursery Class has implemented the Duty of Candour policy and procedures which came into effect within our service from January 2019. The Headteacher and Lead Early Learning Practitioner will ensure that:

- Duty of Candour procedures are carried out as and when necessary,
- Our Duty of Candour Policy is reviewed and up to date,
- Training which is required by the regulation is undertaken by all staff,
- Training/ support and supervision is provided to any persons carrying out any part of the procedure as required by the regulations,
- We report annually on the Duty.

### **Information about our Policies and Procedures**

Where something has happened that triggers the Duty of Candour, our staff report this to the Headteacher or the Lead Early Learning Practitioner who have responsibility for ensuring that the Duty of Candour procedure is followed. The Headteacher/Lead Early Learning Practitioner will record the incident and report as necessary to both: Care Inspectorate & NLC Education and Families/Early Years. If an incident has happened, the Headteacher and staff will set up a learning review to highlight lessons learned. This will allow everyone involved to review what has happened and identify changes for the future.

All new staff will learn about the Duty of Candour at their induction. We know that serious mistakes can be distressing for staff as well as people who use our service and their families. We have Occupational Staff Welfare support in place through our HR Services for our staff if they have been affected by a Duty of Candour incident.

### **What has changed as a result?**

We have updated and made changes to our policies and procedures as a result of Duty of Candour and all existing and new staff members have completed the Duty of Candour Module online.

### **Other information**

This is the 6<sup>th</sup> year of the Duty of Candour being in operation and it has been a learning experience for New Monkland Nursery Class. It has helped us to remember that people who use our nursery service have the right to know when things go badly, as well as, when they go well.

In the spirit of openness, we have placed this report on our website and shared it with our families too.
