Free School Meals and Clothing Grants 2019-20

I wanted to bring to your attention to the above grant.

The clothing grant is a payment grant awarded by Renfrewshire Council to qualifying parents and guardians to assist with the purchase of school uniform. A maximum of one grant will be paid for each child during any school year. The qualifying conditions are listed below:
