

Media Permissions and Digital Learning Acceptable Use Policy

In Renfrewshire schools we want to give our pupils as rich a variety of learning opportunities as possible, including opportunities for Digital Learning. In line with UK GDPR, Digital Learning in Renfrewshire schools includes a range of platforms, such as:

- Glow (Scotland's national digital learning environment)
- · Online video conferencing
- Council-approved apps/resources
- Social media (such as Twitter, Facebook and Youtube)

The internet can harbour dangers and must be used responsibly to keep both our pupils and the network safe. To keep all pupils safe, our acceptable use policy outlines rules that apply to all uses of the internet, social media and to all information sent electronically, including text messages and pictures.

The Rules for ICT and Digital Learning in School

Always follow these rules:

Be secure:

- I will keep logins and passwords to myself and not share them with anyone, even my friends.
- I will always log out when I leave the computer/device.
- I will not look at anyone else's files without their permission.

Be respectful:

- I will always be polite and will not use bad language.
- I will remember that anything I do can usually be traced back to me.
- I will not access, create, store, or distribute files that could be thought of as offensive or indecent, or that harasses or insults others.

Be safe:

- I will not share my personal details or any personal information about other people (home address, phone number etc) in emails, messages, online or with other people.
- I will only send messages to people I know, or my teacher knows.
- I will not arrange to meet people I talk to online.



Be legal:

- I will only put relevant and acceptable materials on to the internet, Glow and Social Media.
- I will never photograph or video staff or other pupils without their knowledge and permission.
- I will never upload photographs or videos of others without their permission.
- I know that bullying using text, multimedia messaging, emails, social networking, or any part of Glow is unacceptable and may lead to very serious consequences.
- I know that I should not copy materials, including videos and pictures from the internet and use them in my own work unless they are copyright free.

Be responsible:

- If I see or hear something that is wrong or that upsets me in emails, on the internet, Glow or Social Media, I will tell an adult and/or use the Report Unsuitable Content button if it is on the screen.
- I will not use internet sites which have unsuitable content.
- I will not record my fellow classmates or school staff without permission.
- I will take good care of school the ICT equipment I am using. If there is a fault or the device is damaged in any way, I will report it immediately to the HT of my school.
- I understand that if I am irresponsible in my use of ICT, the internet, Glow or Social Media and my access may be removed if I break these rules.
