Supporting and Managing Positive Behaviour

We support positive behaviour and a positive environment through;

- Promoting and following a positive and consistent approach to the promotion and management of positive behaviour by the whole school community.
- Encouraging and supporting our children, staff and parents to see themselves as part of our school community
 and recognise their roles and responsibilities within it.
- Providing a stimulating and nurturing environment within which all feel safe, secure and valued.
- Appreciating and following our Rights Respecting School Charter and agreed Class Charters.
- Developing and promoting pupil voice.
- Developing and promoting parental engagement and voice.
- Modelling positive behaviour and adopting restorative practices.
- Offering positive learning experiences within a broad and balanced curriculum that is well planned, prepared, differentiated and supported.
- Supporting our pupils on their life long learning journey and in doing so equipping them with the necessary skills
 to help them to succeed and achieve.

Sanctions and Consequences

Although the emphasis of this guidance is on the promotion and rewarding of positive behaviours and attitudes, we at Sound Primary School recognise that it may be necessary to employ a number of sanctions to enforce our Rights Respecting School Charter and Class Charters to ensure a safe learning environment. Consistency and fairness are vital in the application of sanctions, which should be appropriate to the behaviour.

All behaviour is a means of communication and positive behaviour can be learned. How we as adults choose to respond is very important in promoting and encouraging positive behaviour.

When dealing with all forms of inappropriate behaviour, staff should employ the following strategies;

- Be calm- all children must be dealt with in a calm yet firm manner, referring to which behaviour is not acceptable and the action being taken.
- Make clear that it is the behaviour that is inappropriate and not the individual.
- The first step is to stop the behaviour, the second step is to recall the individuals, rights and responsibilities and the third step is to apply a consequence for the inappropriate behaviour.
- Logical consequences should be applied- a logical consequence is a sanction that is proportional to and fits the inappropriate behaviour.

ANTI-BULLYING

Bullying is not tolerated in Sound School. All reported cases of bullying will be dealt with in line with the Shetland Islands Council Anti-Bullying in Shetland Schools Policy (June 2018)
