## 1 The proposal and consultation process

### 1.1 Proposal

South Lanarkshire Council is seeking views on the following proposal, namely: changing the catchment areas of Newton Farm Primary School and Hallside Primary School to balance pupil numbers more effectively within the two schools and to alter the secondary school those pupils in the rezoned area would attend from Uddingston Grammar School to Cathkin High School.

### 1.2 Decision to undertake the consultation: 22 September 2021

On 22 September 2021, the Executive Committee of South Lanarkshire Council (“the Council”) agreed that a statutory consultation with all stakeholders be undertaken on the proposal within this document.

### 1.3 Consultation on the proposal

Under the Schools (Consultation) (Scotland) Act 2010, if a local authority proposes to alter the catchment area of a school or to vary the arrangements for the transfer of pupils from a primary school to a secondary school, it must undertake a statutory consultation with key stakeholders affected by the proposal. In this instance, the affected schools are Newton Farm Primary School, Hallside Primary School, Uddingston Grammar School and Cathkin High School.

The formal consultation on the proposal within this document will be undertaken under the terms of the Schools (Consultation) (Scotland) Act 2010 (“the Act”). The consultation period will start on Monday 25 October 2021 (with due notice of the proposal to the consultees listed in Appendix 1) and will end on 6 December 2021 (30 school days). Representations must be received by this date to be taken into account.

### 1.4 Virtual public meetings: 9 November 2021 and 10 November 2021

We will hold virtual public meetings on Tuesday 9 November 2021 between 6.00pm and 7.00pm and on Wednesday 10 November 2021 between 6.00pm and 7.00pm. The meeting will provide those in attendance with an opportunity to:

- Hear about the proposal
- Ask questions about the proposal
- Express views about the proposal.

A note will be taken of the views expressed during the public meeting and of any questions asked. In addition to the virtual public meeting, written representations will be able to be made during the consultation period.

### 1.5 Education Scotland (formerly HM Inspectorate of Education, HMIE)

The Council will provide the proposal document to Education Scotland at the start of the consultation period. When the consultation period has ended, the Council will collate all the relevant written and online representations received during the consultation period and oral representations made at the public meeting. Thereafter, the following information will be provided to Education Scotland:

- A copy of relevant written representations made to the Council on the proposal (or summary of them if agreed with Education Scotland)

- A summary of oral representations made at the public meeting
- Other relevant documentation, so far as is practicable.

Education Scotland will prepare a report on the educational aspects of the proposal taking account of the above, and in so far that Education Scotland considers them relevant, any written representations made directly to them.

Education Scotland may also contact and visit the schools affected by the proposal. Education Scotland is required to send its report to the Council no later than 3 weeks (or longer if agreed with the Council) after having received the information from the Council.

#### **1.6 Consultation report**

After receiving Education Scotland's report, the Council will review the proposal taking account of relevant representations received during the consultation period, oral representations made during the public meeting and Education Scotland's report. The Council will then prepare and publish a consultation report which will include a recommendation on the proposal and make it available for inspection. The Council will inform any person who made relevant representations on the proposal of the publication of the report. The consultation report will be published 3 weeks before it is formally considered by the Council.

#### **1.7 Inaccuracies or omissions**

Where the Council is notified or discovers inaccuracies in or omissions from this proposal document, the Council will determine whether relevant information has been omitted or, if there has been an inaccuracy. Appropriate action will then be taken by the Council which may include issuing corrections, issuing a corrected proposal document or an extension of the consultation period. In any of these events all relevant consultees (and where applicable the notifier(s) of any omissions or inaccuracies) and Education Scotland will be advised of the appropriate action. Notifiers of any omissions or inaccuracies will also be given the opportunity to make representations if they disagree with the Council's determination of and any action on the matter, which may result in the Council making a further determination/decision on the matter.

#### **1.8 Implementation date of the proposal**

If the proposal is approved, the catchment change would be effective from August 2022, and parents of any P1 or S1 pupils registering in January 2022 informed of the change to their catchment Primary and Secondary School. Section 4.4 gives further details on arrangements.

## 2 Background to the proposal

The current catchment areas for Newton Farm Primary and Hallside Primary are shown on Appendix 2. These catchment areas came into effect when the new Newton Farm Primary school opened in August 2017.

Appendix 2 also shows the two areas proposed to be realigned to Hallside Primary School from Newton Farm Primary School.

The table below outlines the projected rolls should the proposed changes be approved.

### 2.1 Newton Farm Primary School

Newton Farm Primary School has 14 Classrooms and a 65 place Nursery (ages 2-5 years). With this accommodation (assuming an average of 30 pupils per class), the school could accommodate 420 pupils.

The current roll is 556 and this is being managed by the use of 4 mobile teaching units together with other spaces in the school pending completion of the 7-classroom extension in summer 2022.

The 7 classroom extension will increase the capacity at Newton Farm Primary school to 21 classrooms and (assuming an average of 30 pupils per class), to 630 pupils.

### 2.2 Hallside Primary School

Hallside Primary School can currently accommodate 16 classrooms, and (assuming an average of 30 pupils per class), the school could accommodate 480 pupils.

The current roll (August 2021) is 262. Trends based on the average of the last three years' P1 intake figures suggest the roll will be 254 in August 2023.

### 2.3 Developer contributions

Any Developer Contributions expected, should all known housing developments go ahead, can assist in any works necessary to accommodate the projected pupil roll in Uddingston Grammar School. A feasibility study has begun to establish required works and indicative costs.

Similarly, Cathkin High School has developer contributions available to assist in effectively managing the projected increase in roll, as a result of any catchment change, and any future works required.

### 3 Proposals

#### 3.1 Catchment realignment of Newton Farm Primary School to Hallside Primary School

There are two areas proposed to be realigned and this is highlighted in Appendix 2 of this document:

**Affected streets within the Westburn area:**

Please refer to the area outlined in red in the map within Appendix 2. This includes the following streets of:

Arrol Wynd, Colville Close, Cornfield Court, Dalziel Close, Dalziel Crescent, Dalziel Gait, Dalziel Grove, Dalziel Path, Dalziel Way, Dunlop Street, Eastwood View, Findlay Terrace, Greenwood Avenue, Henderson Avenue, Lockhart Avenue, Lockhart Drive, McKenzie Gate, McIver Street, Mitchell Avenue, Newton Avenue – numbers 2-82, Newton Court, Northbank Avenue, Northbank Street, Redpath Drive, Riverside Place, Westburn Avenue, Westburn Road - numbers 100-227, Westfarm Avenue, Westfarm Court, Westfarm Crescent, Westfarm Drive, Westfarm Gait, Westfarm Grove, Westfarm Lane, Westfarm Wynd

**Affected developments within the Community Growth area – site I, J, K and L:**

Please refer to Appendix 2 of this document and the area outlined in black.

#### 3.2 Alteration of the Secondary school attended by the pupils who fall within the area of catchment proposed to be realigned.

Newton Farm Primary school is associated with Uddingston Grammar School and Hallside Primary School is associated with Cathkin High School.

Under this proposal, the areas of the catchment that are proposed to be rezoned from Newton Farm Primary School to Hallside Primary School would therefore have Cathkin High School as their catchment secondary school. Newton Farm Primary School will remain as an associated primary school of Uddingston Grammar.

### 4 General/Other Implications

#### 4.1 The intended effective date of any revised catchment realignment would be from the school session starting in August 2022.

#### 4.2 As part of the statutory consultation process, a virtual public meeting will be held to fully engage with the local community on this proposal.

#### 4.3 Any entitlement to mainstream school transport will be in line with existing policy of living more than 1 mile from the catchment primary and more than 2 miles from the catchment secondary.

#### 4.4 For those residing in the proposed rezoned area:

- Any current catchment child attending Newton Farm Primary School during school session 21/22 and living in the proposed rezoned area for Hallside Primary School will have the right to remain at Newton Farm Primary School.
- These pupils will then be offered the option of attending either Uddingston Grammar School or Cathkin High School regardless of any catchment change. The option to transition to Uddingston Grammar School would end with the P7s in session 2027/28.
- Thereafter, any further younger siblings enrolling in P1 in respect of school sessions August 2022 through to August 2027 will have the option to enrol at Newton Farm Primary School and have right to attend Uddingston Grammar School.
- Existing transport arrangements will continue.

## **5 Educational benefits - assessment of the likely effects of the proposal**

### **5.1 Education**

The main educational benefit from the proposal is that it would assist with capacity pressures at Newton Farm Primary School and make better use of the underutilised capacity at Hallside Primary School. In terms of secondary provision, the potential for physical building works where required will assist in managing any pupil roll change. There is parental choice in that the option remains for existing pupils not to be affected and that siblings can continue to attend the same school. (Please refer to paragraph 4.4)

Within this proposal, the Council remains committed to ensuring that our schools provide high quality learning experiences which create a fertile environment for children and young people to flourish. Our school leaders strive for excellence, are empowered to build their school community around the needs of their learners and are encouraged to engage with all stakeholders to understand what makes them unique.

### **5.2 Staff**

It is not anticipated that this proposal would have a significant impact either negatively or beneficially on any members of staff in either of the affected primary schools.

## **6 Assessing the impact on the local community affected by this proposal**

- 6.1** Given the assurances in section 4.4 above with regards the right of pupils to remain and the ability to follow siblings, it is therefore anticipated that there will be no negative impact on the local community.

## **7 Employee implications**

- 7.1** Employee resources at each school would continue to be provided by means of existing staffing protocols and agreed management structures.

## **8 Financial implications**

- 8.1** It is anticipated that there will be no additional revenue financial implications as a result of the proposal. Developer contributions expected, should all known housing developments go ahead, can assist in any works necessary.

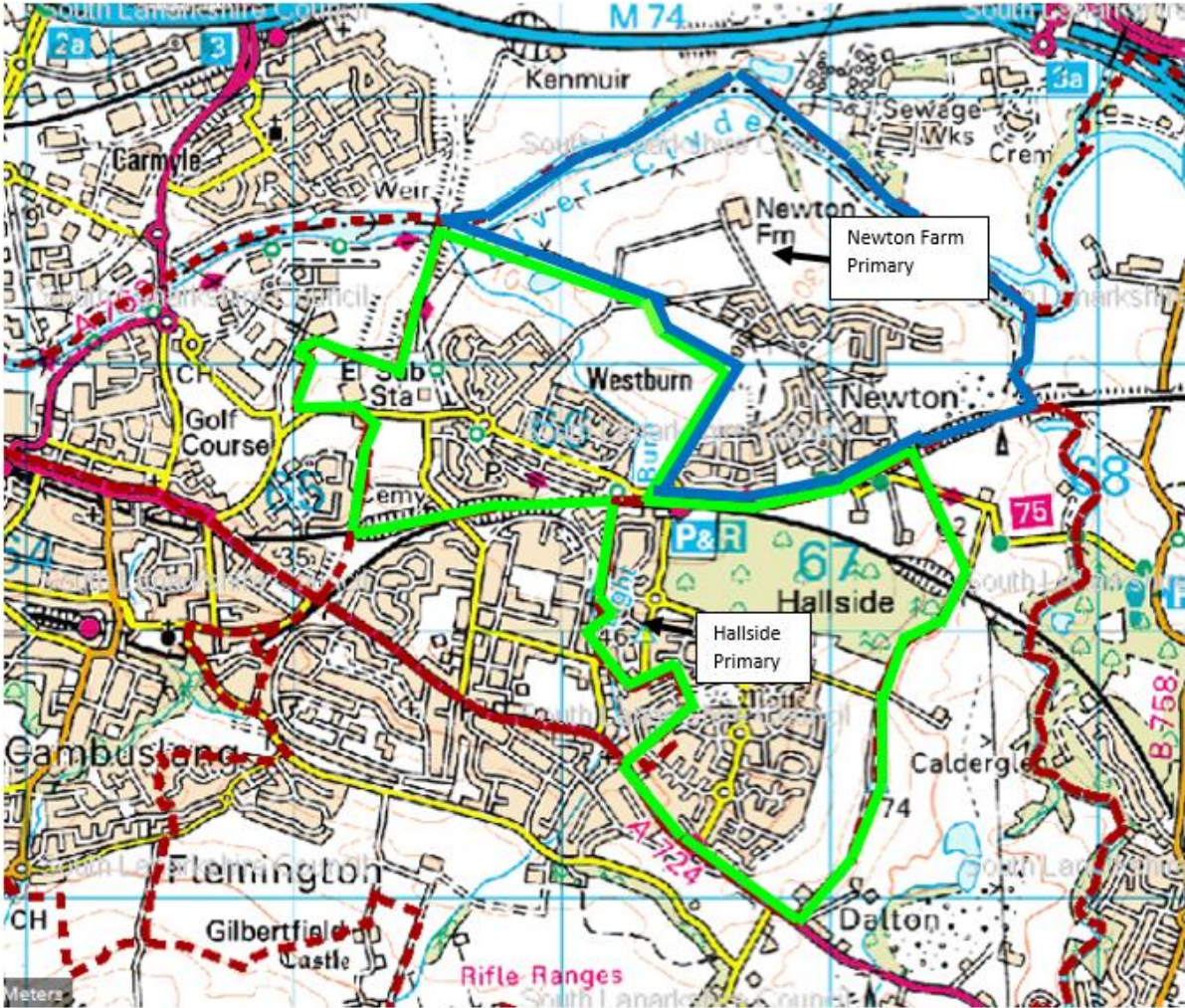
