Guidance and Procedures

Effective learning and teaching in health and wellbeing:

- engages children and young people and takes account of their views and experiences, particularly where decisions are to be made that may impact on life choices
- takes account of research and successful practice in supporting the learning and development of children and young people
- uses a variety of approaches including active, cooperative and peer learning and effective use of technology
- encourages and capitalises on the potential to experience learning and new challenges in the outdoor environment
- encourages children and young people to act as positive role models for others within the educational community
- leads to a lasting commitment in children and young people to follow a healthy lifestyle by participation in experiences which are varied, relevant, realistic and enjoyable

Guidance and Procedures continued

- helps to build positive relationships with other professionals to support the holistic development of each child
- helps to foster health in families and communities through work with a range of professionals, parents and carers, and children and young people, and enables them to understand the responsibilities of citizenship
- harnesses the experience and expertise of different professions to make specialist contributions, including developing enterprise and employability skills.

Assessment, Moderation and Quality Assurance

- Formative Assessment strategies (e.g. consultation with the children).
- Good practice is shared with colleagues through moderation, peer and self- assessment.
- SMT will monitor planning, learning experiences and assessment opportunities through discussions with staff, playroom observations, discussions with the children and sampling individual children's online learning journals and tracking.
