Arrangements for Contacting the School

By Phone:

Should you wish to contact the school about your child please phone the school and ask to speak to a member of the Management Team; either the Head Teacher or Principal Teacher. Your concern will be logged and investigated. A member of the Management Team will make contact with you later that day or the following day to explain the findings.

In Person:

If you wish to speak to a member of the Management Team in person, please contact the school office to arrange an appointment.

Complaints Procedure

You can make your complaint by phone, by email or in writing. We will always try to deal with your complaint quickly however if the matter will need a detailed investigation we will keep you informed of our progress.

We take all complaints seriously and will make every effort to make sure they are dealt with appropriately. If however, you are not happy with the way a complaint has been dealt with, the Head Teacher will invite you to contact Mrs Kathleen McCormick (Quality Improvement Officer) at South Lanarkshire Council Headquarters.

School Visits

If you are seeking a place for your child in Carmichael Primary School, please phone the school to make an appointment with the Head Teacher, they will show you and your child around the school, explain the enrolment procedures and offer you a school handbook. They will outline school procedures, details regarding school uniform and answer any questions you may have about the placement.

Parent Pay and Parent Portal

South Lanarkshire Schools try not to have cash on the premises, all payments for lunches, trips, etc should be made through Parent Pay. We will send you an activation letter once the pupils start in August and are on our computer systems.

Features of our positive school ethos include:


- A strong sense of community

In doing so we would hope that all our pupils acquire the attitudes and skills that are necessary to become the informed citizens of the future and valuable members of the society in which they are growing up.

We reward and celebrate individuals' achievements both within and out with school and provide a welcoming, safe, secure and healthy environment for all. Pupil Leadership Teams

In Carmichael we encourage pupil voice and facilitate the children to become leaders of learning. We do this through the various committees we run. Pupil views are important to us and we encourage all committees to participate in self-evaluation with a view to continually improving learning and teaching in the school. Our vision at Carmichael Primary school is to prepare children for life in the 21st century. We aim to equip them with skills for learning, life and work developing values of effort, kindness and resilience in all that they do.

Rights Respecting School:

Here at Carmichael Primary, we believe through teaching children about their own rights according to the United Nations Convention on the Rights of the Child and the rights of others in turn will raise achievement in school and improve the quality of their lives and the lives of others.

We are working towards our silver Rights Respecting Schools award, which aims to create safe and inspiring places to learn, where children are respected, their talents are nurtured and they thrive.

Our class and playground charters demonstrate the respect we have for others and how we all try to ensure that everyone's rights are met.

Life of the School:

Our children are encouraged to contribute to the life and work of the school and, from the earliest stages, to exercise their responsibilities as members of the community. Our children are encouraged to exercise their right to participate in decision making that affects them. We believe all children regardless of their age or ability can offer experience and knowledge, new perspectives, skills, time and both creative and practical ideas. They are encouraged to contribute as leaders and role models, to offer support and service to others and to play an active part in putting the values of the school community into practice.

Committees:

All children are developing as effective contributors, responsible citizens and confident individuals by fully contributing to the life of the school and the wider community. Children have active roles in the various committees and working parties throughout the school, e.g. Eco Committee, Rights Respecting Schools Committee, School Improvement Team, JRSO, Participatory Budget Team, and Reading Schools Group. These committees meet regularly in order to gain pupil views and have their voices heard.









Restorative Practice:

In Carmichael Primary we are committed to using Restorative Practice techniques in the school particularly when dealing with challenging behaviour and conflict. It focuses on building and repairing relationships rather than on managing and controlling behaviour.

It is really about asking the following questions:

- What happened?
- What were you thinking?
- How did you feel?
- Who else has been affected?
- What do you need/to do?


The emphasis on 'we' is crucial, because it implies that all those affected by what has happened are also involved in finding the way forward.











Attendance

Every effort should be made to ensure that your child attends school during term time. Please contact the school as soon as possible if your child is unable to attend school. It is important for the school to work with parents /carers in encouraging children to attend school. All absences are required by law to be recorded. Absences will normally fall under two categories – authorised or unauthorised absence. In cases where your child is unable to attend school, parents are asked to follow the procedures below.

- If you know in advance of any reason why your child is likely to be absent from school, please let us know either in writing or by telephoning the school.
- Notify the school first thing in the morning when your child is going to be absent. Let the school know the likely date of return and keep them informed if the date changes.
- Inform the school of any changes to the following:
 - Home telephone number
 - Mobile number
 - Emergency contact details

Requests for your child to be absent from school to make an extended visit to relatives either in the UK or overseas must be made in writing to the head teacher, detailing the reason, destination and duration of absence and arrangements for their continuing education. On these occasions the pupil will be marked as an unauthorised absence.

Parents may request that their children be permitted to be absent in order to celebrate recognised religious events. Advance notice should be provided to the school when children will be absent. Appropriate requests will be granted, and the pupil noted as an authorised absentee in the register.

Information on emergencies

We make every effort to ensure the school remains open during term-time for pupils. However, on occasions circumstances may arise which can affect the school. Schools may be affected by, for example, severe weather, power failures or through any other circumstances that may impact on the school day. In such cases we shall do all we can to let you know as soon as possible. We shall keep in touch by the most appropriate method at the time normally through text message, and via our social media channels.

In cases of severe weather in the morning such as snow and a heavy frost and if there is a reason the school cannot open in the morning at the normal time, we will adopt the protocol for a delayed start until 10am.

If this is the case a message via Parent Portal and on the council's website will be posted.

The Council's website <u>www.southlanarkshire.gov.uk</u> will be used to let you know if the school is closed or has a delayed start. Further information will be provided later in the day as to whether the school will be open as normal the next day.

Things we need you to do:

• It is important for parents/carers to let the school know of any change to your mobile/home telephone number and change of address.

If for any reason, you are unsure if the school is open visit the website www.southlanarkshire.gov.uk or email education@southlanarkshire.gov.uk

a. Your commitments

We ask that you:

· support and encourage your child's learning – ask them what they have been doing.

· respect and adhere to the school's policies and guidance.

• accept your responsibility to respect staff who work in the school and for the school to be proactive in taking forward its commitment to care for and educate your child.

Family holidays during term time

Every effort should be made to ensure that your child attends school during term time. Please contact the school as soon as possible if your child is unable to attend school.

Family holidays should be avoided during term time as this both disrupts the child's education and reduces learning time. If holidays are taken during times when the school is open parents should inform the school in advance by letter.

If your child is taken on a family holiday during term time, then in line with Scottish Government advice this will be classified as an unauthorised absence. However, in exceptional circumstances schools may register a family holiday during term time as an authorised absence when for example, parents are able to demonstrate they have been unable to obtain leave during the school holiday period.

Clearly, absence with no explanation from parents will mean that the absence will be recorded as unauthorised.

In our approach to raising attainment and achievement it is recognised that attendance at school is something that should be continuously encouraged. Parents/carers, children and the school all have a part to play in encouraging and stressing the importance of attendance at school.

6) Parental involvement/Parent Council

Parents, carers and family members are by far the most important influences on children's lives. Children between the ages of 5 and 16 children spend only 15% of their time in school! Research shows that when parents are involved in their child's learning, children do better at school and throughout life. Parental involvement can take different forms but we hope you share the same aims and agree that by working together we can be partners in supporting children's learning.

As a parents/carers we want you to be:

- Welcomed and given an opportunity to be involved in the life of the school;
- Fully informed about your child's learning;
- Encouraged to make an active contribution to your child's learning;
- Able to support learning at home;
- Encouraged to express your views and involved in forums and discussions on education related issues.

Every parent with a child at school is automatically a member of our parent forum. The parent council is a formal group, with a constitution, and acts as the parent voice of the school. 7) The Curriculum

Curriculum for Excellence is the name given to the curriculum in Scotland for all children and young people aged 3-18. It is a forward looking, coherent, more flexible and enriched curriculum that provides young people with opportunities to engage with the knowledge, skills and attributes they will need to flourish in life, learning and work.

The curriculum places learners at the heart of education and at its centre are four fundamental capacities – successful learners, confident individuals, responsible citizens, and effective contributors. It includes all of the experiences that are planned for children and young people to support the development of their skills, wherever they are being educated, for example in the family and community, pre-school centre, nursery and school.

In taking this forward our school will work closely with South Lanarkshire Education Resources and other services to enrich the curriculum, to provide the best possible education for all children and young people. We wish you to feel confident that your child is encouraged and supported to develop their literacy, numeracy and other skills whilst they attend our school. The curricular areas are as follows:

- · Expressive arts
- · Languages and literacy
- · Health and wellbeing
- · Mathematics and numeracy
- · Religious and moral education
- · Science
- Social studies
- Technologies

Our learning and teaching activities are based on the outcomes and experiences in the guidelines that all schools have for Curriculum for Excellence.


Level	Stage

At Carmichael Primary School we aim to actively engage our children in their learning as this is when learning is the most meaningful for them. Children experience **challenge and enjoyment** in all that they do; '**breadth**' in relation to the different learning experiences the children engage with; **progression** throughout their learning, building upon prior knowledge at a steady, challenging and relevant pace for each individual; **depth** of learning to allow children to develop specific skills that they can transfer to other aspects of learning; **personalisation and choice** in what and how they want to learn; **coherence** in their learning which allows children to see the links between what they are learning and the real world; and **relevance** of what they are learning and why it is important for them now and in the future.

Approaches to learning

We use a variety of different approaches to teaching and learning to engage our learners. **Active learning** is part of daily teaching and learning in our school where children are actively engaged in all aspects of their learning across all curricular areas. All activities are created to stimulate, motivate and appropriately challenge our pupils and relevant links are made across curricular areas and to real life contexts to make learning more meaningful.





Interdisciplinary learning allows topics to encompass other curricular areas. This year some of our class topics have been World War 2, Space, Black History and My Body. Learning in these topics has made links in many curricular areas and allows children to apply learning from one context to another.





ICT

As a school we use **ICT across the curriculum** which involves using different types of technology to engage learners and provide different ways of learning. We are well resourced and have PCs, iPads, laptops, chrome books, interactive whiteboards and GPS tracking devices for Geocaching. We strive to keep up to date with new developments in technology and use these in every day learning and teaching.



Outdoor Learning

We take advantage of our beautiful, local, rural surroundings to embrace **Outdoor Learning**. All of our pupils make good use of the woodland area to the rear of our school where an outdoor learning classroom has been set up in Carmichael Estate. In our last inspection our outdoor learning was praised as a high-quality provision which allows children to apply their knowledge and skills across their learning in a stimulating and exciting way.



All staff within the school are highly motivated. Teaching staff use **responsive planning** which allows them to incorporate what the children want to learn and build on prior knowledge ensuring the motivation, interests and individual needs of children are being met. Responsive planning allows teachers to reign in on the particular interests of children and gear learning experiences towards these whilst still teaching the required elements of what they have to learn.

Health and Wellbeing's Relationships, Sexual Health and Parenthood Programme (RSHP)

Our local authority is committed to the provision of quality sex education in accordance with National Guidance, we use the national resource for Relationships Sexual Health and Parenthood (**RSHP**). This will form a key element of our personal, social and health education and will provide knowledge and understanding of the nature of sexuality and the processes of human reproduction within the context of relationships based on love and respect. All parents have the right to withdraw their children from RSHP lessons. Please notify the school in writing if you wish to do so at the time. If you wish to view the materials we use, please contact the school.

Our programme for RSHP covers:

Early years of primary school:

- Awareness of the ways in which bodies grow and change
- Uniqueness of their body
- Where living things come from
- Family and special people who care for them

Middle stages:

- Exploring changes in the body
- How human life begins
- Being part of a family
- Dealing with bullying situations

Upper stages:

- Physical and emotional changes at puberty
- Body image and self-worth
- Understanding of own developing sexuality
- Developing an awareness of gender identity
- Changing nature of friendship
- Dealing with sexual feelings
- Menstruation, pregnancy and birth

Religious and moral education

Religious and moral education allows children to explore the world's major religions and views and to consider the challenges posed by these beliefs and values. Through developing awareness and appreciation of the value of each individual in a diverse society, religious and moral education promotes responsible attitudes to other people. This awareness and appreciation assists pupils in counteracting prejudice and intolerance.

A programme of study for religious and moral education has been devised for our school based on the Curriculum for Excellence National Guidelines. Integral to this guidance is the principle of mutual respect. The diversity of belief and tradition provides an ideal context in which pupils can learn about, and so learn from, what is important in the lives of themselves and others. South Lanarkshire's guidance recognises and welcomes diversity and promotes respectful understanding.

The school programme is very largely based on Christianity and Christian Festivals as well as looking at customs and celebrations of several other main world religions. We focus mainly on Judaism and Islam for our study of other world religions.

Spiritual, social, moral and cultural values (religious observance)

Rights of parents / carers

Scottish Government Ministers consider that religious observance complements religious education and is an important contribution to pupils' development. It should also have a role in promoting the ethos of a school by bringing pupils together and creating a sense of community.

There is a statutory provision for parents to withdraw children from participation in religious observance. This right of parents' wishes will be respected and where a child is withdrawn from religious observance, schools will make suitable arrangements for the child to participate in a worthwhile alternative activity.

Parents may request that their children be permitted to be absent in order to celebrate recognised religious events. Advance notice should be provided to the school when children will be absent. Appropriate requests will be granted and the pupil noted as an authorised absentee in the register.

Clubs and Extra Curricular Activities

Throughout the school year there will be a range of clubs that pupils can participate in during lunch times or at the end of the day, for example, coding, multi-sports, lego, baking and dance club. These may change each year and are usually delivered by school staff, Active Schools coaches, or parent volunteers, we might occasionally invite other groups or organisations to deliver clubs depending on funding. Clubs are usually free of charge for pupils.

Every second year some of our pupils attend a twelve week block of swimming lessons at Lanark Leisure Centre, this will be P4/5/6 depending on pupil numbers. Every second year our P6 & P7 pupils attend a residential trip for three days, most recently this has been to Lockerbie Manor. Each year we deliver the Bikeability training to P7 pupils in the last term.

8) Assessment and tracking progress

We want to share with you how your child's learning is progressing. We do this through two parent information evenings per session and a formal report towards the end of the session.

Assessment is an integral part of day to day learning and teaching for children and staff. Assessment is vital to ensure children are progressing in a challenging and progressive way, assessing not just what they know but how well they know it. Assessment is a tool used by teachers to help plan and prepare programmes of study and learning activities that challenge and extend children's' knowledge. It also allows teaching staff to evaluate the effectiveness of their teaching and the resources that they use.

Throughout all learning activities children will always:

- Know what they are learning, why they are learning it and how they can be successful,
- Be given feedback on how well they have done and what they can do to make it better,
- Be involved in the decision making process of their next steps in learning.

As a school, we use a variety of formative assessment techniques on a daily basis to help inform next steps for all children. We carry out regular summative assessment to allow pupils to build a portfolio of evidence of achievement of a level within Curriculum for Excellence.

Tracking learners' progress

Carmichael Primary School tracks all learners' progress across core curricular areas of literacy, numeracy and health and wellbeing. This allows us to have a clear understanding on how well learners are progressing. It enables next steps in learning to be identified and informs the planning and reporting process while ensuring appropriate support and challenge are in place for all pupils.

9) Reporting

We will provide parents with a written report each session so that you can see what your child has been learning and how they are progressing. In addition, there will be two parents' meetings across the session which offer you the opportunity to discuss how your child is progressing. As well as these opportunities to hear how your child is progressing there will be informal feedback provided throughout the school session in the form of newsletters/Sways, class showcases, performances, community events and opportunities to share pupil achievements.

Our 'pupil reports' will help you to get to know more about the curriculum which each child follows and will describe their strengths, achievements and areas for development so you know what encouragement and support you can give.

We welcome any comments or additional information from parents to help us provide the best possible education for your child.

10) Enrolment and Transitions

Enrolment – how to register your child for school.

To register your child for school you should complete our online registration form. This can be done using the South Lanarkshire website.

If you have any difficulty in identifying your catchment school, please email Edsuppserv.helpline@southlanarkshire.gov.uk

The online registration form will ask you to provide each child's full birth certificate and two pieces of recent official documentation both containing your permanent home address for example a utility bill, council tax statement, housing rent card, child benefit documentation.

Proof of where the child lives may also be needed.

If your child is due to start school in August 2024, you can enrol online from Monday 8 January 2024. Your catchment school will contact you between Monday 15 to Friday 19 January 2024 to confirm your enrolment.

If your child attends the nursery of your catchment school, please do not assume that they will automatically be transferred. <u>You must register them as normal</u> at the school that is in the catchment area for your home address.

If parents want their child to go to another school, they must enrol in the first instance with their catchment school and intimate that they wish to make a placing request. An online placing request form is available from the SLC website – <u>www.southlanarkshire.gov.uk</u> or by contacting <u>edsuppserv.helpline@southlanarkshire.gov.uk</u> or phone 0303 123 1023.



Change of School/Placing Request

Normally children attend the school in their catchment area. However, there are times when parents may wish their children to go to other schools. If you wish your child to go to another school, then you may make what is known as a 'placing request'. If you live in South Lanarkshire and decide to submit a 'placing request', we are unable to reserve a place in your catchment school until the Council have made a decision on the 'placing request'. Please note if your 'placing request' application is unsuccessful and all places at your catchment school are filled you will be offered a place at the next nearest appropriate South Lanarkshire School.

Please note that if an application for a 'placing request' is successful then school transport is not provided.

If you move outwith your catchment primary school a 'request to remain form' must be completed. If you move outwith your catchment primary, this may affect your right to transfer to the associated Secondary School. Please note the secondary school is determined by the pupil's permanent home address and chosen denomination. If you require further information, please contact Education Support Services on edsuppserv.helpline@southlanarkshire.gov.uk or 0303 123 1023.

Transition from primary to secondary school

Pupils normally transfer from primary to secondary school between the ages of 11½ and 12½, so that they will have the opportunity to complete at least 4 years of secondary education. Arrangements are made by the school to transfer children to the associated secondary school as determined by their home address. Parents of P7 children will be informed of the transfer arrangements made for their child to attend secondary school.

We will also provide you with information at this time on events designed to support P7 children before they move on to secondary school.

The associated secondary school for pupils who live within the Carmichael Primary School catchment area is Lanark Grammar.

Children currently in P7 will receive a copy of Lanark Grammar School's handbook in January and, be able to visit Lanark Grammar School for two days in June preceding their transfer as part of the transition programme. They have the opportunity to meet Lanark Grammar School staff at Carmichael Primary when staff visit our school. Some of our pupils fall in the catchment for Biggar High, or parents choose to make a placing request to Biggar High, in these instances we will do everything we can to liaise with Biggar High and ensure pupils access all transition activities.

Every two years our P6/7 pupils take part in a residential outing to an outdoor centre allowing them the chance to work with other pupils from local schools who will be transferring onto secondary education at the same time as them. In spring 2024 we will take our P6/7 pupils on a residential visit to Lockerbie Manor Outdoor Centre with pupils from Braehead Primary. This allows our pupils to try out a range of challenging activities they normally do not have access to and helps to build self-esteem, resilience and confidence.

We participate in a range of activities giving our pupils the opportunity to get to know other pupils from other Lanark Learning Community Schools. Our P4-7 pupils also take part in rugby, football, cross country, and dance events which are organised for pupils within Clydesdale schools by Active Schools. We also work closely with our partner school, Braehead Primary.

11) Support for Pupils

Getting it right for every child.

Getting it right for every child (GIRFEC) supports families by making sure children and young people can receive the right help, at the right time, from the right people. The aim is to help them to grow up feeling loved, safe and respected so that they can realise their full potential.

Most children and young people get all the help and support they need from their parent(s), wider family and community but sometimes, perhaps unexpectedly, they may need a bit of extra help. GIRFEC is a way for families to work in partnership with people who can support them, such as teachers.

If you have any concerns about your child's wellbeing, you can speak to the named person who will work with you to provide support and decide how to move forward. Your school will let you know who this is. It is likely to be the Head Teacher in a primary school and a principal teacher (pupil support) in Secondary.

Support for All (Additional Support Needs)

In Carmichael primary staff ensure that all pupils are challenged and supported to achieve their full potential, recognising the importance of motivation, positive relationships, and confidence for our pupils. Teachers and support staff use a range of teaching approaches and resources to ensure pupils progress academically, socially, and emotionally. Some pupils may require interventions to support their learning at points during their time at primary school. Where support is required, we work closely with parents and partners across Education, Health and Social work as appropriate, to ensure the best outcomes for our pupils.

All of our actions are guided by South Lanarkshire Council's Additional Support for Learning guidelines. Any parental enquiries about Additional Support for Learning can be directed to the Head Teacher, who will be happy to discuss your concerns.

South Lanarkshire Education Resources have published a series of leaflets available which cover information for parents and carers about the Additional Support for Learning Acts.

In keeping with duties set out in the Education (Additional Support for Learning) (Scotland) Act 2004 (as amended) the guidance states that handbooks should specifically mention Enquire, the Scottish advice service for additional support for learning.

Enquire is funded by the Scottish Government to provide information on the framework for supporting children who require additional support for learning and to encourage positive partnerships between families, schools and local authorities to ensure children get the right support.

Attachment Strategy for Education Resources

Attachment – what we do to support children and young people

South Lanarkshire Council Education Resources is committed to improving outcomes for children and young people by creating emotionally supportive learning experiences in our nurseries and schools.

The Education Resources Attachment Strategy supports the action in the 'Getting it Right for Every Child in South Lanarkshire's Children Services Plan 2021-23', following the launch of the Attachment Strategy in 2020, to provide staff training in Attachment and Trauma based practice.

What does it set out to do?

The aim of the strategy is to promote better experiences of attachment for South Lanarkshire's children and young people and to ensure that all education practitioners understand the importance of attachment theory and its application and how positive relationships can make a difference to outcomes.

How can I find out more?

South Lanarkshire Council Education Resources have published a series of leaflets and posters for establishments and for parents/carers which aim to share information on attachment theory and on how this informs the ways in which we support children and young people.

These are available in schools and on the SLC Staff Learning Centre Sway accessible by teachers and staff.

12) School Improvement

Following a period of self-evaluation with regards to pupil attainment and school improvement, every session Carmichael Primary School produces a School Improvement Plan highlighting the areas the school will focus on the following session. This plan is then worked on throughout the following school year and reviewed and reported on in the school's annual Standards and Quality Report.

Pupil Equity Funding (PEF)

The majority of our PEF funding is used to enhance our support staff hours to work directly with pupils, delivering a range of interventions as appropriate, based on formal assessment data and teacher professional judgement. Our PEF budget has also been used to purchase ICT equipment, play resources, and transport to access educational experiences.

Participatory Budget

The participatory budget is a minimum of 5% of our Pupil Equity Fund, this year we allocated 8% of our PEF which is £588. The Participatory budget is discussed and agreed on by our whole school community annually, usually in October.

In October 2023 our school community voted to use our participatory budget for this year to resource after school and lunchtime clubs for pupils. Money will be used for resources and where necessary to pay for coaches to come into school to work with our children.

13) School policies and practical information

Healthy eating is something that the school supports and a range of meals are available at lunchtime that meet the Nutritional Requirements for Food and Drink in Schools (Scotland) Regulations 2020

All primary aged pupils are also offered a free breakfast within their school. The selection available includes cereal, toast, fruit and milk.

For their lunch each day pupils have the option to choose from two hot meal options, a snack option. These are all served with vegetables or side salad. All meals also come with fresh chilled drinking water, salad, seasonal fruit and depending on the day - soup or a dessert.

Milk will be available for those pupils entitled to free school meals through the free school meal eligibility scheme at morning break or lunchtime. If you have not applied for free school meals milk currently costs 29p.

Pupils in:

- Primary 1 5 receive a free school lunch (without milk).
- Primary 6 7 meal cost is £2.05

School lunches and milk can be paid for through your Parentpay account or Paypoint facilities in local shops.

NB School Meal prices are reviewed annually and may be subject to change.

Adapted diets

If your child within Nursery, Primary or Secondary requires an adapted diet for medical reasons please speak to the school/nursery office who will provide the request form for you to complete. In addition, if you have a halal or vegan diet request for your child, please speak to the school office who will provide you with a request form.

Free School Meals

Children of parents who receive the following benefits are entitled to a free lunchtime meal and milk for their child:

Income Support, Universal Credit (where your take home pay is less than £726 per month), Job Seeker's Allowance (income based), Employment and Support Allowance (income related), Working Tax Credit and Child Tax Credit (where your gross annual income does not exceed £8,717 as assessed by the HM Revenues and Customs), Child Tax Credit Only (where your gross annual income does not exceed £18.725 as assessed by the HM Revenues and Customs) or receive support under Part VI of the Immigration and Asylum Act 1999.

If you are in receipt of Housing Benefit and/or Council Tax Reduction from us there is no need for you to apply online, we will use the information we hold to automatically award free school meals (P6 to S6) and/or school clothing grants (P1 to S6) to eligible families.

We would encourage parents of children who are in receipt of any of the above benefits to take up this opportunity of having a meal provided for their child when they are at school. Arrangements are in place so that children who receive free meals are not singled out and we encourage all children to remain in school at lunch time.

South Lanarkshire Council also offers a free Breakfast service. The service runs from 8.15am to 8.45am in Carmichael Primary each school day. Pupils who arrive on school transport can get toast when they arrive.

School uniform

We ask all parents/carers to support the school by encouraging your child(ren) to adhere to the agreed dress code and the wearing of our school uniform. The wearing of a school uniform helps promote the identity of the school in the local community and helps create an ethos of sharing and pride in the school.

In addition, the wearing of a uniform helps towards increasing the protection of all pupils. The wearing of a uniform helps staff and the pupils to distinguish between who belongs to the school and those who may be visitors. This enables staff to approach and identify visitors more readily and helps in trying to offer a safer environment for pupils and teachers alike.

Equality of opportunity is an important aspect of the life of the school. Any proposals on the dress code and on what constitutes the school uniform will be the subject of discussion with the Parent Council and where appropriate consultation with parents, pupils and staff.

There are forms of dress which are unacceptable in all schools such as:

- the wearing of football colours
- clothing with slogans that may cause offence (anti-religious, symbolism or political slogans)
- clothing which advertises alcohol, tobacco or drugs
- clothing which can be deemed unsuitable in terms of health and safety grounds such as shell suits, combat style clothing, dangling earrings, loose fitting clothes particularly in practical classes
- articles of clothing that could be deemed to inflict damage on other pupils or be used by others to do so
- footwear that may damage flooring.

For the benefit of new entrants the uniform is listed below.

Many parents use ALJ clothing who are based in Lanark <u>https://www.aljonline.co.uk/</u>, however, uniform does not need to have logos and can be bought in most supermarkets.

We have preloved uniform available in school to reduce costs for parents and to reduce the amount of good quality clothes that end up in landfill! Our preloved uniform is managed by our parent council Parents can contact the school or the parent council at any time to check what stock we have or pass on clean, good quality, preloved items to be added to our stock.

The last Friday of every month is non-uniform day, parents and carers, are invited to make a donation of £1.

P.E Kit

For P.E children should wear a navy or white T-shirt and navy or dark coloured shorts. They should also have a pair of soft shoes or gym shoes which are only worn in the classroom or gym hall. This protects flooring and ensures a hygienic learning environment for everyone.

Forest Kit

Pupils will be outside weekly for outdoor learning and should bring forest kit with them. This should be wellingtons or other waterproof boots, and a waterproof jacket as a minimum. Some pupils bring waterproof trousers, as well as a hat, gloves, and an extra fleece in the colder weather. We go out all year round, we do not go out if there is a weather warning in place.

Allergies

A significant number of children and young people in our schools will have allergies and it is important that parents keep the school fully informed on these matters. Please inform the school of any allergies your child may have.

Allergies can present in a variety of ways and can occur at any point in a person's life. Symptoms range from mild to severe. Children and young people known to have an allergy with moderate to severe symptoms will likely have a Health Care Plan drawn up by the NHS. This will detail symptoms and appropriate interventions.

It is vital that parents share this information with the school and continue to provide any updated information. Where symptoms are mild and a Health Care Plan is not in place, parents should still continue to liaise regularly with the school on any new triggers, medications and actions required.

In all cases, our employees need to know your child's symptoms, treatments and any actions required to help prevent exposure to the allergen and minimise the risk of allergic reactions.

Employees in schools will receive training on allergies and will liaise with parents and NHS on any additional specialist training required.

In supporting children and young people with allergies, school employees will operate in accordance with South Lanarkshire Council's Safe Systems of Work / risk assessment and national guidance on the administration of medicines.

Support for parent/carers

Clothing grant

In certain circumstances the Council provides support to parents/carers for the purchase of school wear.

Transport

South Lanarkshire Council has a policy of providing school transport to primary pupils who live more than one mile by the recognised shortest walking route from their catchment school. This policy is more generous than the law requires. This means that the provision of transport could be reviewed at any time. Parents who consider they are eligible should complete a form online <u>www.southlanarkshire.gov.uk</u> or contact **0303 123 1023**. These forms should be completed and returned before the end of March for those pupils starting the school in August to enable the appropriate arrangements to be made. Applications may be submitted at any time throughout the year and will be considered by Education Resources.

A privilege transport scheme is operated for mainstream school contracts where a pupil is not entitled to free school transport. Privilege transport will only be granted providing there is spare capacity on an existing school contract and will be from and to designated pick up and drop off points. Privilege transport will not be provided where a service bus is used on the school run. Any spare capacity will be allocated using agreed priorities. Pick-up points

Where school transport is provided it may be necessary for pupils to walk a certain distance to the vehicle pick-up point. Walking distance in total, including the distance from home to the pick-up point

and from the drop-off point to the school in any one direction, will not exceed the authority's distance limit for school transport.

It should be noted that it is the parent's responsibility to ensure their child behaves in a safe and acceptable manner while travelling in and alighting from the vehicle. Misbehaviour can result in your child losing the right to school transport.

Parents are asked to note that South Lanarkshire Council does not provide transport for those pupils who attend school via a placing request.

Insurance for schools – pupils' personal effects

South Lanarkshire Council is concerned at the level of claims being received for loss or damage to pupils' clothing or personal effects. Parents are asked to note the Council's position in terms of insurance for pupils' personal effects:

(i) Theft/loss of personal effects

The Council is not liable for the loss or theft of pupils' clothing or personal effects for example mobile phones, tablets etc. and any items are therefore brought into the school at the pupil/parents' own risk.

Parents can assist by ensuring that valuable items and unnecessarily expensive items of clothing are not brought to school.

Teachers and other staff have been advised not to accept custody of any such items.

The same principle applies to musical instruments and other equipment used for activities within the school, which belong to the pupil, but are brought into the school. Parents should be aware that if such equipment is left in school, it is done at the pupil/parents' own risk.

In the case of valuable items such as musical instruments, parents should ensure that these items are covered by their own household insurance.

(ii) Damage to clothing

The Council is only liable for damage caused to pupils' clothing where the damage has resulted from the negligence of the Council or one of its employees. Claims arising otherwise will not be accepted by the Council's insurers.

Promoting positive behaviour

It is the responsibility of staff within the school to ensure that parent council members, parents and pupils are involved in the creation of a positive school ethos that encourages good behaviour. Equally, the school whilst trying to promote positive behaviour must support young people should incidents or bullying occur. Parents have a significant role to play in working with the school so that teachers, parents and pupils know what is expected of them in trying to change the behaviour and attitudes that contribute to bullying behaviour.

Our approach is to create an environment where better behaviour will encourage better learning. The school, along with the support of parents, can work together to create a learning environment which young people can enjoy and feel safe.

Incidents of bullying should be reported to the school immediately so that each alleged incident can be looked at. Together we can work towards creating a safer school for children and staff.

In addition, a guideline (Promoting Positive Relationships and Behaviour) has been produced to support all teaching and support staff and inform them of their roles and responsibilities in respect of dealing with the small number of children and young people who display challenging behaviour. Early identification is crucial so that intervention can be provided to support children and young people to help them address their issues and concerns. Staff training is provided to help develop the skills needed to respond to and manage challenging behaviour. A wide range of appropriate staff development opportunities has been developed for this purpose.

Child Protection

All staff in educational establishments in South Lanarkshire Council receive an annual Child Protection update and are required to follow the advice and guidance contained within relevant Education Operating Procedures. They must also complete a mandatory Learn on Line Course "Child Protection in Education".

South Lanarkshire's children's services partnership works together to support children, young people and their families so that children grow up in communities where they are safe, healthy, active, achieving, respected, responsible and included, and have the opportunity to achieve their full potential. They are committed to continuously improve our services to ensure children, young people and their families get the right support at the right time.

Sometimes children and young people need additional help to make sure that they are *"cared for and protected from abuse and harm in a safe environment in which their rights are respected"* (CPC South Lanarkshire Child Protection shared vision). The Child Protection Committee has the overarching responsibility to ensure that agencies individually and collectively work to protect children and young people as effectively as possible.

All staff have a responsibility to report any suspicions that a child has been abused or is at risk of harm, abuse, or neglect. Robust procedures and guidance are in place to support education staff to: -

- be alert to signs that a child may be experiencing risks to their wellbeing,
- report concerns to the head of establishment or the child protection coordinator without delay.
- be actively engaged in support and protection and development of wellbeing.

If you would like more information, or have a concern of a child protection nature, please contact the head of the educational establishment which your child attends.

General Data Protection Regulation as supplemented by the Data Protection Act 2018 (GDPR)

Information on pupils, parents and guardians is held by the school to enable the teaching, registration and assessment of pupils as well as associated administrative duties. The information is stored and used as per the requirements of the GDPR, with South Lanarkshire Council defined as the data controller. The Council have established a data protection policy that applies to all of its school. Education Resources has also prepared a privacy notice (below) which sets out how we will deal with personal information as part of our statutory function as an education authority. Privacy Notice

Introduction

In line with the General Data Protection Regulation (GDPR) we have produced this privacy notice to inform you how we deal with personal information as part of our statutory function as an education authority.

The Council has a legal obligation to deliver effective education services to children, young people and adult learners in South Lanarkshire. In order to do this we need to collect personal information about children, young people and their families so that we can help them to learn and keep them safe.

Using your personal information

The Council is a "controller" of the personal information you provide when enrolling for a nursery or school, applying for an education service or participating in groups or activities provided by Education Resources.

Information we collect from you about you and your child at enrolment

When you enrol for a nursery or school, we ask for the following information:

- parent/carer contact details (name, address, phone, email);
- the child's name, date of birth, gender and address;
- information about medical conditions, additional support needs, religion and ethnicity;
- any information you may wish to provide about family circumstances.

Information we collect at other times

We will also collect information at other times such as when you apply for a benefit, request a services or other support. We will provide an additional privacy notice at these times.

- If you apply for an education service or benefit, such as school transport, free school meals, clothing grant, placing request or EMA, we will also ask for personal information as set out above. We will also ask for information about your income for education benefits applications.
- If you make a request for additional support such as an educational psychologist or other support for learning we will ask for more detailed information to allow us to provide the most appropriate support for your family. This may include information about family circumstances or medical conditions.
- If there are concerns about your child's wellbeing and/or your child has needs that may require additional support, we will wish to work with you to collect and consider information to enable us to help you get the right support at the right time in line with the Getting it right for every child approach.

We require this information to ensure that children and young people are educated appropriately, supported, and that we take account of their health and wellbeing. We will also ask you to update this information annually and to tell us when there are changes to your details.

Information that we collect from other sources

As an education authority and as part of our statutory function in accordance with our legal obligations, we receive information from other sources such as the SQA, the NHS or Social Work about you or your child, this includes:

- exam results and assessment information;
- information about health, wellbeing or child protection.

Why do we need this information?

We need this information so the Council can ensure it is delivering education services appropriately to all learners:

- for the education of children, young people and adult learners;
- for teaching, enrolment and assessment purposes and to monitor the educational progress of children, young people and adult learners ;
- to keep children and young people safe and provide guidance services in school;
- to identify where additional support is needed to help children, young people and adult learners with their learning;
- to maintain records of attendance, absence and behaviour of children and young people (including exclusions);
- to support children and young people moving on each year from nursery to primary, primary to secondary and when they move or leave school;
- to help us develop and improve education services provided for young people, adult learners or families
- In accordance with our legitimate interests as an education authority we will also use your information to create statistical reports.

We will share your information with:

As an education authority and as part of our statutory function in accordance with our legal obligations we will share information with other bodies or parts of the Council, including:

- The Scottish Government and bodies such as Education Scotland, Scottish Qualifications Authority, Skills Development Scotland and other organisations that support children and young people's learning;
- Other parts of the Council when required for services such as school meals, school transport, education benefits and with Social work in connection with any child protection concerns we become aware of;
- The NHS, to support health initiatives in accordance with the legal obligation on the Council in terms of section 39(3) of the National Health Service (Scotland Act 1978;
- South Lanarkshire Leisure and Culture Limited, where children and young people are participating in sports and leisure activities;
- Other schools/local authorities if a child moves or transfers to another school the Council has an obligation to pass on information with regards to pupil records to the new school/local authority.

You have the right to access your personal information as well as the rights of rectification, erasure, restriction and the right to object.
