Using Your Personal Information

The adapted menu plans have been approved by parent/carers and passed to the school office, Facilities Officer and Assistant Facilities Officer and catering staff. The school office will be notified if there are any changes/updates regarding the adapted diet procedure.

Facilities services will keep the records relating to the adapted dietary requirements, allergy or intolerance information for as long as the child is at school within South Lanarkshire Council. Thereafter they will be destroyed in line with the Council's confidential waste policy.

Personal information will only be processed when it is lawful to do so.
