Although only a few objects the composition is busy with overlapping and repeated shapes within the painting.

Media Handling and Brushwork: Gris works mainly in oils paints but also used collage pencil and gauche paints. Often using more than one at once means is work is known as mixed media. Gris uses diagonal brushstrokes to convey the angles in this painting. Gris deliberately shows these brushstrokes to "fraction" or

Line:

"shatter" the image.

Diagonal lines cut through this image distorting our perception of reality. The lines are confident and carefully placed by the artists. The broken objects give the viewer the sense that they are looking through broken glass or a reflection.

Tone: Tone in this imagine is quite dramatic with lots of white

and black paint applied next to one another. The tone around each object is smooth and glowing, this emphasises the shape on the objects in the still life.

The shadows on the ellipses clearly show the direction of light in this still life. Only the knife breaks this rule with the shadow

cast in the opposite direction.

This fractured image plays around with our idea of reality; we try to piece the image back together trying to figure out where the objects really lie

Colour: Gris used muted colour, working with a mainly tertiary

Texture: There is a fine painterly texture throughout this image shown by the artist's brushstrokes. These brushstrokes are even and all flowing in the same direction.

The paint in this image is applies thickly and can clearly be seen in its layers. This shows that Gris is a skilled artist as the thick

paint is definite, controlled and equal throughout the painting.

Pattern: This image shows a clear pattern in the line around the

objects. Gris uses a similar and <u>stylised</u> outline to emphasis his objects.

Pattern is also present in the diagonal lines that cut through the image creating repetition of similar shapes. The repetition of colour can also be seen to make up pattern in this abstract

Form: As this is an example of cubist painting the idea of view object from one angle has been abandoned. The shattered image allows us to see objects at slightly different positions shows the 3D form of the objects. Although there are 3D qualities in the ellipse of the objects the painting has been simplified and stylised into geometric shapes rather than
