2 -Vision 2030

The Vision 2030+ report sets out Scotland's vision for LfS in educational settings through to 2030, building upon five strategic recommendations in the Learning for Sustainability report.

1. All learners should have an entitlement to learning for sustainability.
2. In line with the new GTCS Professional Standards, every practitioner, school and education leader should demonstrate learning for sustainability in their practice.
3. Every school should have a whole-school approach to learning for sustainability that is robust, demonstrable, evaluated and supported by leadership at all levels.
4. All school buildings, grounds and policies should support learning for sustainability.
5. A strategic national approach to supporting learning for sustainability should be established.

3- The United Nations Sustainable Development Goals

The 2030 Agenda for Sustainable Development, adopted by all United Nations Member States in 2015, provides a shared blueprint for peace and prosperity for people and the planet, now and into the future.

There are 17 Sustainable Development Goals (SDGs), which are an urgent call for action by all countries. They recognise that ending poverty and other deprivations must go hand-in-hand with strategies that improve health and education, reduce inequality, and spur economic growth – all while tackling climate change and working to preserve our oceans and forests.

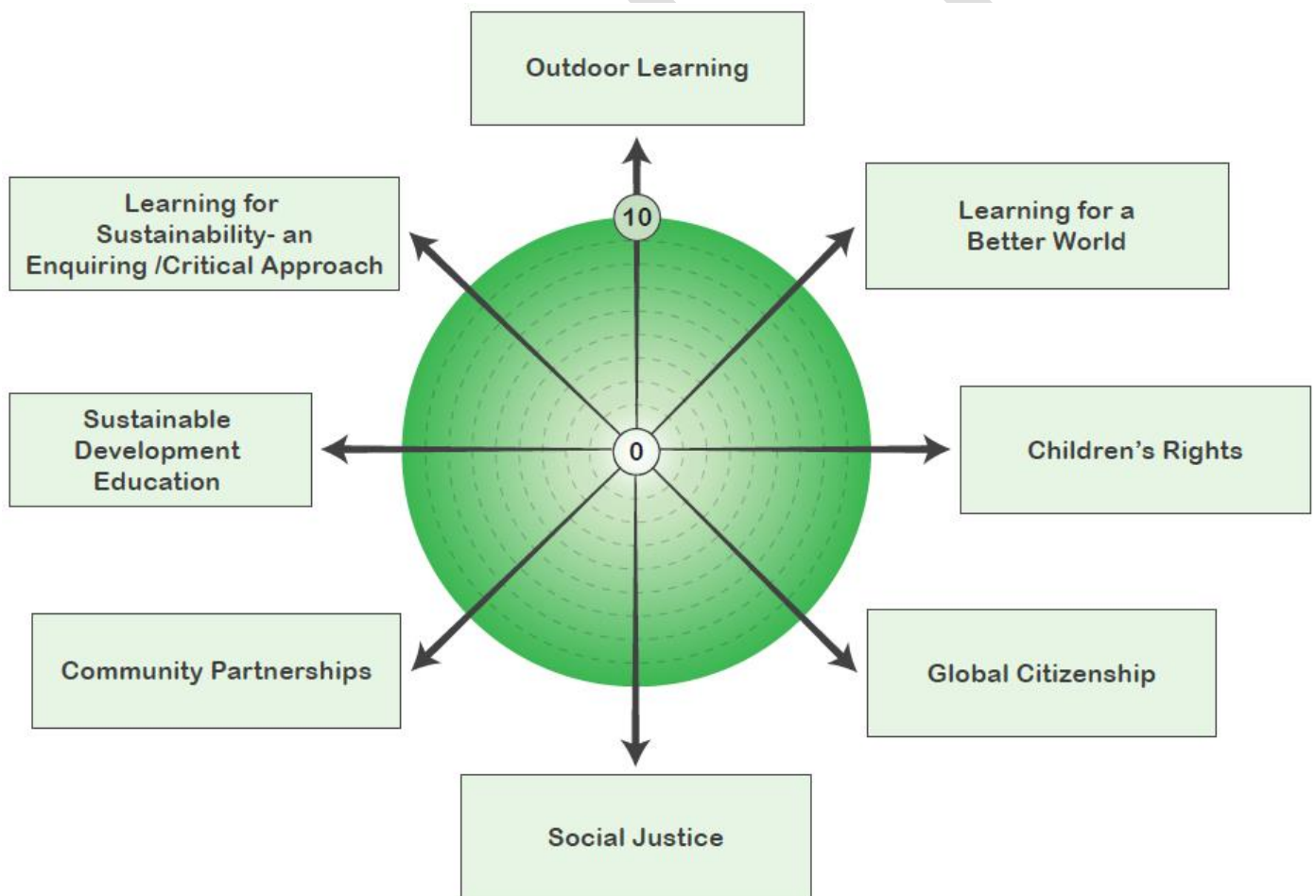
